The Club does not share members' data with any external organisation except BE, EBA, EWBA, ECBA, ECWBA and THL for the purposes of membership and affiliation.

You have the following rights concerning this data, namely:

- > To request a copy of the data held about yourself from the Membership Secretary, to be provided within one month;
- The correction of any inaccurate data, to be done within one month;
- The erasure of the data should you leave (or fail to re-join) the Club;
- To withdraw your consent to the use of the data for contact purposes;
- ➤ To report any suspected breach of data security to the Club General Secretary.

You have the right to refuse consent to the Club contacting you in any of the ways given but should you do so, you need to be aware that the Club may not be able to contact you about events, matches or urgent issues, such as late cancellation of games.

The Club website will hold no openly available personal information unless it has previously gained specific consent from named individuals to publish their details.

We are asking you to confirm that you have read the GDPR Policy and to confirm your consent to the Club using your data as described above and in the Policy.
