#### 9.8 Purchase Orders/Requests for work to be undertaken

The Clerk advised all Councillors the Responsible Officer is the only person who can request work be done and/or issue purchase orders. Cllrs are not authorised to do this and if they do, the Parish Council is not obliged to pay for the work/purchase as there is no valid contract between the contractor/provider and the Parish Council

#### 10. Parish Plan

During the open forum part of the meeting, Andrew Marshall spoke to the Parish Council about a working group which has been set up to revise the Parish Plan. The last Parish Plan was in 2006. A plan has been devised which has 8 phases to it, with completion by the end of December 2023. They have discussed what needs to be done with Stratford District Council. No outside funding is available to undertake the plan. Therefore they will be seeking funding from the Parish Council to undertake this work, approximately £2,000 (£1,600 plus £400.00 contingency). They will initially require a small amount to start with to pay for an insert in the Hut News and then to pay for stationary items for a drop in at the Village Hall. If the initial drop in is not well attended or residents do not show any commitment to the Parish Plan being renewed the project will stop there.

The Parish Council can fund the drop in and the insert in the magazine, however, no allowance has been made in the budget for a monetary request of £2,000, so this will need to be discussed.

#### 11. Upper Lighthorne Heath Healthcare Provision

A meeting will take place on 20<sup>th</sup> January 2023 between SDC, the NHS Integrated Care Board (ICB), Sir Jeremy Wright, and representatives from South Warwickshire Health Matters (representing 19 parish councils) to discuss the provision of GP and other health services, as part of the new Upper Lighthorne development of 3,000 houses. All District and County councillors, together with the local MP are united and strongly support the view that Upper Lighthorne should have its own GP Practice and health facility, as proposed in the approved planning permission for the GLH development. The health facility is required to reduce the pressure on local medical centres. A recent survey of local communities also indicated the need for a health centre at Upper Lighthorne.
