# Minutes of the Meeting of Bowes Parish Council held at Bowes Village Hall on 23<sup>rd</sup> June 2021

The meeting commenced at 7.30pm

# 1. **Apologies**

# 2. **Minutes of the Meeting**

held Wednesday 19<sup>th</sup> May agreed to be a true record, approved by Cllr Tipping, seconded by Cllr Redfern.

## 3. **Matters arising** (unless dealt with later in the agenda)

20 mile an hour zone in Bowes – Sam Chaters a Senior Civil Engineering Technician from DCC replied as follows:-

The introduction of 20mph speed limits are typically reserved for residential housing estate locations and in some cases commercial town centre areas, as the Department for Transport advise that 20mph speed limits must be what are termed 'self-enforcing' by virtue of the road layout. In this respect, 20mph speed limits would only be considered where average speeds are at or below 24mph.

On residential/distributor roads within housing estate areas where average traffic speeds are greater than 24mph there would be a requirement, where design standards permit, to introduce costly physical traffic calming measures such as road humps/chicanes together with 20mph Speed Limit 'Zone' signs at every entrance/exit to the zone to ensure that the 20mph speed limit is self-enforcing.

The use of 20 mph advisory part-time speed limits on main/distributor roads would be permissible outside of facilities for vulnerable road users such as schools that would otherwise be unsuitable of a full-time 20mph speed limit or zone. Part-time advisory speed limits require the use of flashing amber signs which when displayed advise motorists to travel at 20mph. However, the normal speed restriction for the road remains the legally enforceable limit. The introduction of part-time advisory 20mph speed limits in the vicinity of schools are supported by educational and social marketing campaigns.

Clerk to e-mail Sam - We would like to have the 20mph flashing signs at the top and bottom of the road and the top of the back lane covering as long a distance as possible.

Leasing Council owned land – We have received some advice from Roger Taylor at Wellers Hedleys Solicitors. They have said that a lease of 7 years or more has to be registered at the Land Registry. This involves preparing a lease, and a plan which complies with Land Registry requirements and deducing the Parish Councils title to the land, this will increase the costs. In the circumstances it is probably better to have a lease for under 7 years, although if the tenant is looking for grants this period may not be sufficient. If the lease is for conservation purposes kit is unlikely to be protected under Agricultural or Landlord and Tenant act legislation. Wellers Hedleys can provide a lease for £700.00 plus VAT and any disbursements. This figure assumes that the lease will be subject to scrutiny by both parties but not replying to each point made by individual councillors on the draft!

Due to the costs involved it was decided not to lease the land, however we like the idea of having the land used for conservation purposed and asked for volunteer to manage the land. Cllr Tipping stepped forward for the post of conservation officer. Cllr Hughes and Cllr White approved the motion. This post will be renewed at each Annual General meeting. Any materials purchased for this purpose will be reimbursed via the usual procedure.

Dog litter bin – request has been submitted but the bin has not yet arrived. Clerk to chase.

We started our meeting this evening in the cemetery to look at the trees, it has been decided to drastically cut the trees on the west side of the steps along to the wall in October November after permission has been sought, as a starting point.

#### 8 Allotments

Charles Raine has replied – the Chaiman of the Lords in Trust who has responded in the positive on the condition that all consents are obtained in regard to Planning and Highways and there is actually a need to install another gate.

The gate is required for the 3 allotments at the north end of the field. The temporary style that we provided is now unsafe and has never been suitable for wheelbarrow access. We will ensure that the width of the gate is no more than 3 feet and that the walls are properly finished on either side. The gate will be close to where the stile is now. The allotment holders will be completing the work, Cllr Carlisle will meet them on site. Cllr Hughes has confirmed that highways consent is not needed.

One of the allotment holders has moved out of Bowes, he must formally return his plot, we have a waiting list. Clerk to e-mail him and the first person on the waiting list.
