

Residents priorities Survey.



Analysis of feedback.

- Number of questionnaires printed and delivered 290
- Number of documents returned for analysis 119- 41%
- Total number of adults who contributed 216
- Number of adults over 65 who contributed 94
- Number of young persons under 18 who contributed 8
- Estimated number of adults living in the Parish 600
- Percentage of adults in Parish who responded 36%
- Spoilt return questionnaires not analysed Nil
- Total comments submitted by respondents Over 650

Residents comments under "additional comments" at the end of the questionnaire.

- One hundred and thirteen returned questionaires completed "additional comments" at the end of the survey.
- One hundred and eight comments were related to road safety along the Alkham Valley road and the rural road network within the Parish.
- Only six "additional comments" referenced other subjects.
 - Two of the six comments thanked those involved in the project
 - Four of the six comments included, Litter concerns, maintenance of roadsides other than Newlyns Meadow, a proposal that the plan should cover the next 30 years, a need to upgrade the village hall and church garden, concern over the church rising damp, involving the garden club to beautify church and village hall, Parish to run an online events calendar.

Road Traffic within the Parish of Alkham

- The subject of road safety and traffic within the Parish of Alkham was clearly identified by the Traffic Action Group in April 2018 and the identified problems are still clearly the top priority for most residents.
- The project team propose that the significant amount of additional feedback raised by residents at the Village Hall open discussion day in autumn 2018 plus the additional 108 comments received in this survey are immediately passed over to the Traffic Implementation Group for review.
- Recommendation to Parish Council: Where appropriate, the working copy of the TAG report should be revised, reviewed and updated as an immediate priority and then progressed with KCC.

- The ability for RESIDENTS to COMMENT anonymously on the questionnaire resulted in a very successful engagement with residents.
- OVER 650 comments and suggestions were made on the survey forms in addition to completion of the "structured answer boxes".
 - The comments will be consolidated with other similar comments, then summarised by topic in a document to be considered alongside the more structured questionnaire output presented tonight, plus earlier feed back from the village open day, traffic and Byway survey reports.
- It is not planned to release individual comments to the public as writing styles and the many personal references made could either identify or lead to speculation about the authors.
