As you know, I and colleagues work to support the Merle Boddy Centre, to give provision of Dementia and Mental Health Care, for Swaffham and surrounding villages. Indeed, the MBC is specifically identified in the Neighbourhood Plan (page 56/6.5.2). This suggests something of recognition and importance for the role of MBC in the community.

The future of the MBC as a going concern, is presently the subject of intensive fiscal care, having suffered difficulties during and post Covid. The team of volunteer Directors and Supporters are presently engaged on business scrutiny, with potential positive support from Norfolk County Council.

However, the future is certainly balanced on a threshold, as fiscal realty is assessed and possible reorganisation is considered and evaluated. It is a 'fight' to maintain services and the future of the amenity. We need appropriate support and there must be a role for both Swaffham and Breckland Councils, to play a part in this cause? Presently, NOTHING is forthcoming from either - apart from a reasonable Tenancy arrangement with Breckland.

I quote Item 6.5.5 of the Neighbourhood Plan. 'As the town grows (and that is certainly the case!), provision of services **must** be addressed, in particular ****** and Social Care.

So please may I/we seek a debate in Council - along with Breckland Councillors - to identify and deliver a fiscal response to this 'obligation' and the present circumstances? There must be a case for such as a specific interim Grant and/or ongoing Annual Support Grant? It has been said that Swaffham is a responsible Dementia care community. Well, apart from volunteer activity and revenues from those in need, there is absolutely NOTHING forthcoming from the two Councils.

Where can we, could we or should we go forward from here? We at MBC will appreciate an opportunity for such debate and to present fiscal analysis to show the situation as it is.
