The Parish Council were consulted on this application and recommended refusal. NYCC Highways Area 4 have also been consulted and reported no objection. Members were extremely disappointed with this response as the Chair and Clerk had a meeting with Melanie Farnham, Area 4 Highways Engineer in August where it was agreed that Area 4 would look to carry out engineering on Swinton Grange Lane i.e. passing places due to the increased traffic. The engineer agreed that additional vehicles from businesses should be kept to a minimum.
