1. Applications

SE/18/00157: Berrys Maple, Pease Hill, TN15 7ET – Creation of a subterranean link, external alterations to the existing annex to enclose open sided barn and erection of new entrance gates.

Cllr F Cottee PROPOSED "The Parish Council has no objections to the proposed entrance gates and subterranean passage provided that they comply with current planning policy. In particular, the structural integrity of the listed farmhouse should not be put at risk."

"The Parish Council is concerned at the current level of development of the site compared with its 1948 size. Nevertheless, it has no objection to the proposed enclosing of existing open sections of the stables to provide additional accommodation provided that it complies with current planning policy. However we note that the proposed new East-facing window is very close to the neighbouring Cottage and will result in overlooking and loss of privacy. We therefore request that this window is replaced either by a high-level window or by obscured glass.

We also note that there are apparent breaches of Building Regulations, as the stables are built on the boundary line of the adjacent property and drainage from the stable building roof is directly onto the neighbours land" Responses:
