## **Ivinghoe Parish Council**

Minutes of the Ivinghoe Parish Council Meeting held at Ivinghoe Town Hall on Monday 10<sup>th</sup> January 2022 at 7.15pm.

#### C/001/22. Chairman's Welcome.

The Chairman opened the meeting and welcomed everyone.

#### C/002/22. Public Question Time.

A resident stated the drawings for planning applications 21/04636/APP and 21/04748/APP were incorrect and the Chairman asked them to directly with Buckinghamshire Council Planning Department.

An Ivinghoe Aston resident questioned about the Ivinghoe Neighbourhood Development Plan and in-filling in Ivinghoe Aston and expressed concerns over losing the character of the village and speeding traffic.

An Ivinghoe Resident expressed concern over the size of the proposed six houses, feeling that the large new houses are not in keeping with nearby priorities.

An Ivinghoe Aston resident raised concerns over sewage and electricity power outages.

An Ivinghoe Aston resident raised concerns over the speed limit for the Village, rather than two speed limits and the increase in volume of traffic.

An Ivinghoe Aston resident raised concerns over the increase in attempted burglaries in the village, whether there are plans to introduce CCTV and ANPR and to introduce new highway signs to deter burglars. The Chairman shared the residents' concerns and suggested a Neighbourhood Watch Scheme. The resident reminded everyone to report the suspicious activity and crimes to the police. The Clerk will contact Highways about CCTV.

Apologies were received from Councillors Lott and Ketteridge.

## C/008/22. Highways, Streets and Transport (including Lighting and Speed Watch).

Ivinghoe Freight Strategy – no update.

Community Speed watch is on hold currently as some equipment is replaced. Thames Valley Police have attended three times recently with the traffic camera and have issued letters to offenders.

Gully emptying – no update.

Ivinghoe Parish Council will undertake a consultation with residents located near the proposed new parking spaces in Station Road between 14<sup>th</sup> – 31<sup>st</sup> January 2022.

Salt Bins – Councillor Jellis will check the level of salt in the bin and Councillor Bexson will check the levels in Ivinghoe Aston and report back to the Parish Clerk.

### C/009/22 Footpaths, Bridleways, Trees and Playgrounds.

Whistlebrook Clearance – no update the Chairman will speak to the Head Teacher at Brookmead. Ivinghoe Christmas Tree – Councillor Jellis suggested the tree should be relocated as this obstructs the gateway. Councillor Bexson raised concerns that the tree could die if it is moved. It was decided not to move the Christmas Tree, this will be monitored.

Ivinghoe Simply Walks – this has relocated to Pitstone and the Chairman was disappointed there has been no consultation.

#### C/010/22. Allotments.

It was agreed to allow an allotment holder to level her path, the allotment holder must undertake a risk assessment and ensure the work is undertaken safely.
