Minutes of the Parish Council meeting of Witton and Ridlington Parish Council on 12th November 2025 at 7:00pm at Witton and Ridlington Village Hall

4. Chairman's Report

The Chairman attended the Coastwise Presentation held at Walcott, although the main points of the meeting were in connection with Walcott, the effects of coastal erosion in Witton, should Walcott succumb to the sea, were discussed. There are plans to try and protect Walcott but not Happisburgh. It appeared that Private and Public money would need to be put into any plans to protect the coastline, The public views are needed and suggestions required to agree to a way forward. However it appears that a lot of the suggestions already made will be unaffordable.

The meeting will be adjourned for a period of 15 minutes) to allow Members of the Public to speak, to receive District and County Councillors reports and any Councillors with prejudicial interests to speak.

Cllr Lucy Shires, Norfolk County Council has sent her report to council, a copy of which is available on the council website.

Norfolk Community fund has been launched and groups are urged to apply for it. The Mayoral election in May 2026, after which more money towards infrastructure should be available, Unitary elections are likely to be 2027 with the new unitary council implemented by 2028. It appears that Parish Councils may have to take on more responsibilities

A Parishioner asked if people could look out for their neighbours, especially the elderly and those that live alone.

A concern was also raised about the increased numbers of Heavy Goods Vehicles using the small roads in the parish. The verges were being destroyed, roads were being damaged and the roads left covered in mud. After a short discussion, Cllr Lucy Shires said she would make enquiries about installing "unsuitable for Heavy Goods Vehicle" signs and Cllr Sands said she would liaise with the farming

community to ask them to avoid sending large vehicles along the small roads. The conversation then moved to discuss the speed of other vehicles travelling through the village. An estimate to carry out a traffic survey had been received and was likely to cost £5000, Cllr Shires suggested that before this was undertaken that more signage be installed and the local police asked to carry out speed checks in the area. It was agreed that the clerk would liaise with the public and Cllr Shires to work out the best places for signage to be installed

Residents were asked to be aware of the increase in fly tipping in the area and to report any concerns they have to the police
