Two storey extension to dwelling and new vehicular access.

Proposed two storey extension, roof alterations and general improvements (re-application to extend approval RR/2011/864/P.)
Comments: Committee raised no objections to this.
RR/2014/830/P Pilgrims Rest - land rear of, Park lane
Proposed new house (alternative proposal to planning permission no. RR/2013/619/P)
Comments: Not consistent with policies DS1, GD1 from the existing local development framework in that it harms the amenities of the adjacent properties and it is incongruous with the appearance and setting of the heritage assets immediately adjacent in the Town's conservation area. It harms the residential amenities of the neighbouring properties and detracts from the historic built environment in contravention of draft core strategy policy OSS5. The photovoltaic panels on the roof would not be sympathetic to either neighbour and would be prominent at first floor roof level. These panels are not shown on the elevations and hence the drawings presented are misleading; drawings SK200/201 indicate that the zinc panels are not in keeping within a conservation area. The bulking of the proposed property is also in direct conflict with the previously passed application where the previously approved proposals were all with the ground floor sunken below the ground. Battle Town Council raises strong objection to this proposal.
