MINUTES OF HORSMONDEN PARISH COUNCIL PLANNING MEETING HELD IN HORSMONDEN VILLAGE HALL, HORSMONDEN AT 7.30 P.M. ON 17th JUNE 2015

1. APOLOGIES FOR ABSENCE

Cllr Davis was unable to attend owing to a business commitment. This was proposed as an acceptable reason by the hair and voted for unanimously.

2. PUBLIC SESSION

Mrs Collett had sent in a copy of her letter to TWBC objecting to application TW/ 15/503684/FULL for 2 Woodgate Mews. She felt that the additional windows applied for in the application would over look her property and also that by providing extra accommodation through a loft conversion, this would cause additional parking which would add to the number of cars parked on the road nearby.

3. PLANNING

3.1 Applications/Submissions:

Cllr March proposed that the application TW/ 15/503684/FULL be brought forward for discussion first. Unanimous. The Council discussed the points raised in Mrs Collett's letter, however they did not feel that the new windows would present an over looking problem, as they were of the velux type often used in loft conversions, which were slanted in the direction of the roof and make overlooking difficult. Also they did not think that a loft conversion would necessarily lead to more parking requirements. After a discussion therefore, the following recommendation was made:

Comments:	Recommended refusal. Over development on the property. The proposed build is of excessive height and excessively large, with inappropriate dormer windows and inappropriate first floor with stairs. Situated too far from the main dwelling.
