Minutes of a meeting of Kirklinton Parish Council held at Fir Ends School on Tuesday 23 February 2016.

#### **DECLARATIONS OF INTEREST**

Mr I Armstrong declared an interest Agenda Item 8 (b) – Planning Application No. 16/0102 and took no part in the ensuing discussions and outcome.

**MINUTES** of the Meeting held on Tuesday 24 November 2015 were approved as a correct record and duly signed by the chairperson.

#### **MATTERS ARISING**

(a) Play area - Monthly Inspections.

Monthly Inspection Report forms were distributed to those Members next on the rota.

(b) Highways Issues raised at last meeting.

The Clerk reported that work to resolve the flooding issues on Scalebyhill Road and at Kirklinton Terrace appeared to have been completed. However, flooding at Rigghead remained an issue but the Highways Authority was well aware of the problem.

No response had been received regarding the visability issues at the crossroads on the A6071 adjacent to the old Fir Ends School.

The Clerk also reported that the Police had been made aware of the parking issues along Skitby Road.

(c) Grant request to Carlisle City Council (Councillor David Shepherd).

The Clerk reported that David Shepherd had approved a grant of £200 towards proposed work in the play area. The Chairman thanked David on behalf of the Parish Council for his support.

(d) Transparency Code.

The Clerk reported that he had submitted a grant application to CALC for financial assistance towards the cost of setting up a website for Kirklinton Parish Council. The application was bidding for £437.

In the meantime the Clerk had been made aware of a company (Hugo Fox) offering to host a website free of charge. After extensive enquiries, including references from two Parish Councils who already use the facility it was decided, in consultation with Mike Jack to take up their offer. Whilst the website, in the form of a template is free, populating the site with all the necessary information will be the Parish Council's responsibility. Hugo Fox will provide support backup.
