



# Hedgerley Parish Council

Minutes of Parish Council Meeting held on Monday

13<sup>th</sup> October 2014, in the Memorial Hall, Hedgerley

- 1. To approve Minutes of Meeting held on 8<sup>th</sup> September 2014**  
**Subject to one minor alteration, Minutes were approved as a true record, and signed.**
- 2. County Councillor**  
**Safeguarding children -**  
**PH said that a further 5.8m is coming out of reserves; working on an improvement plan. Major savings in the home school transport. This has not been considered very successful and quite a few parents have voiced their concerns.**  
**BCC are still trying to save money.**  
**DB asked if any action had been taken on Mrs Sarah Heath letter regarding her two children having to attend separate schools. PH said that he had spoken to Trevor Boyd at BCC and even though the children would still continue to attend separate schools, it had been arranged that the older child would be taken and brought home by taxi.**

- 5. Clerk's information items**
  - Mobile library – nothing to add at present; EJE dealing**
  - BKV presentation – went off very successfully. Councillors agreed that a letter of thanks be sent to the judging panel and thanks be sent to John Lovelock for providing the photographs and sending the information to the press.**  
**TE and MER told the meeting that they had asked Kevin Booker of the White Horse if the BKV plaque could be put on the pub wall. He said as it was a listed building, this would have to be considered. TE had spoken with a John Brush, the Listed Building officer and he thought the pub had a bit too much going on and suggested it go on the wall next door. Councillors didn't agree with this idea, so it was decided that it would go on the Environmental Sign board as there would be a good place for the plaque on either of the legs. TE and MER to investigate.**

Clerk had contacted the HPC Insurance company who said that the Parish Council were in no way legally liable; they have not been negligent. There is no evidence and the lady did not know how the accident happened as she did not witness it.**
