The parish council have been alerted by ROSPA that the swings were unsafe to use. Cllr P Davies taped up and placed notice on equipment to prohibit use. A quote has been received for £290 to replace two posts and the crossbeam.

The Chairman has also been in conversation with former parish councillor M Jones who has been liaising with local residents.

After some discussion it was **PROPOSED** by Cllr V Amos to hold a formal public consultation, at January meeting. In the meantime proceed to get equipment repaired based on quote received. Cllr P Davies **SECONDED**. All **AGREED**.

14. ACCESS ROAD BROOKSIDE

The Chairman met with two Severnside representatives this afternoon about the access road maintenance. They have agreed to include the repair on the schedule of works in the next rota drawn up (within next quarter).

15. ROAD SAFETY

Road safety on the B4380 raised item 5.

ACTION there are potholes on the Ironbridge Road close to the junction with Ishmore Lane.

Also there are visibility issues for emerging traffic from Wroxeter Lane onto Ironbridge Road at the Roman site because of the overgrown verge and hedge looking South down Ironbridge Road. <u>ACTION</u> clerk /Chairman to raise with Shropshire Council Highways team.
