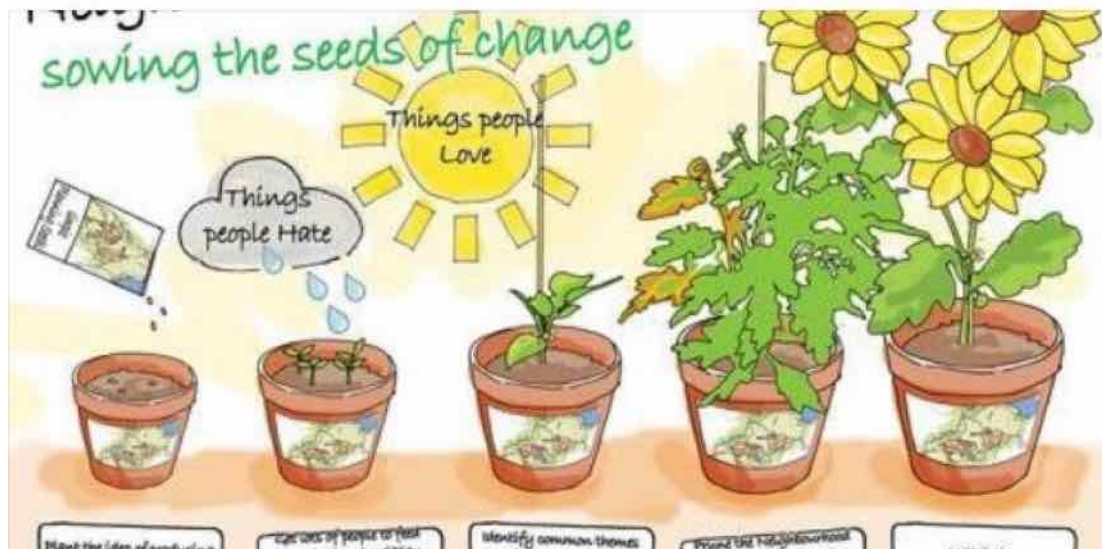

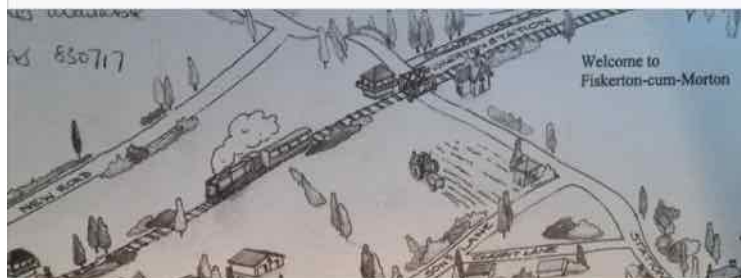

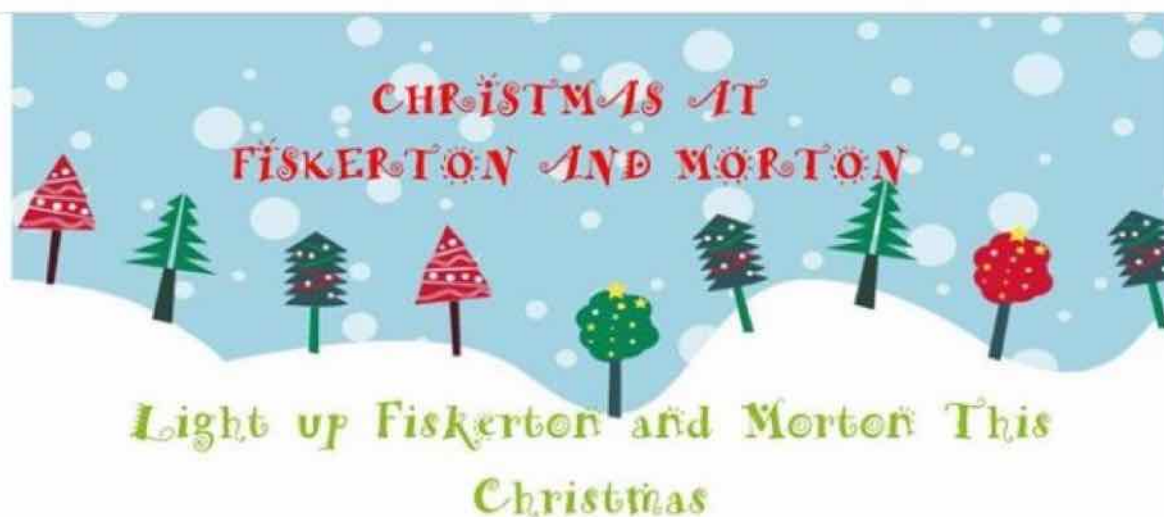

### *Community Engagement Event*

### **Village Green Christmas Light Switch-on - 2017!**

Over the Christmas period the Neighbourhood Plan Steering Group wanted to take the opportunity to organise two community social events as a means of raising the profile of the Neighbourhood Plan with all sections of the community in both villages.



The first event was the first Christmas Light Switch-on at the village green in Fiskerton, on Saturday 9<sup>th</sup> December, which was made possible by the recent provision of electrical power on the green, by the parish council.

A fair amount of organisation was required before the event which was mainly undertaken by Cllr Jacqui Holtam and Sarah Angell with help from several other members of the steering group and the Sports and Gala Association (who kindly lent their marquee and PA system). By and large things went to plan, however, a few of the arrangements were changed due to unforeseen circumstances, such as the brass band, who were unable to attend at the last moment.

All residents were informed of the event by the inclusion of an A4 flyer in the November edition of the *Tons Tatler* (see Appendix i). The event included refreshments, for which a small charge was made, (mulled wine, hot dogs and mince pies) and a chance for the children to visit Santa. Under three's were given an illuminated balloon and over three's a glow stick. Residents could also make a donation to the Newark Children's Bereavement Centre.

Prior to the 'switch-on', members of the NP Steering Group chatted to those attending and distributed copies of the first questionnaire (see Appendix ii). This explained what the NP is trying to achieve and asked residents to let the Steering Group know what they like about their village, what they don't like and what changes they'd like to see in the future. Residents

were invited to return the completed forms to boxes in the village shop, the Full Moon pub in Morton or the Bromley in Fiskerton.

Approximately 100 adults and 40 children attended the 'switch-on' between 4pm and 5pm on despite near freezing temperatures. The lights were switched on at 4.45pm by Santa.



All this happened to a background of festive music. It had been intended to sing Christmas carols but as the weather was so cold it was decided to proceed with the switch-on. Despite this all those attending appeared to enjoy the occasion. The flyer advertising the event also promoted a competition for the best seasonally dressed house and mentioned the second event – a Lantern Walk on 28<sup>th</sup> December ending at the Full Moon pub in Morton where the winner of the competition will be announced.

## FISKERTON CUM MORTON NEIGHBOURHOOD PLAN

### What is a Neighbourhood Plan?

Neighbourhood Plans allow local people to take control over the future of their area. It will include a vision for the future of our villages, that may be delivered by a number of policies and projects. The Neighbourhood Plan is a legal document that will be used by officers at the Newark & Sherwood District Council when determining planning applications and by developers wishing to build in the area in conjunction with the National Planning Policy Framework and the NSDC adopted Local Plan.

Importantly, the entire content of the Neighbourhood Plan must be based on what local people have said they wish to see happen and change in the area, with these views collected through a comprehensive engagement programme that includes all members of the local community.

### What can the Neighbourhood Plan do?

The Neighbourhood Plan will control the use of land within the local area over a long period, for the next 15 years. The Plan could cover where new homes, shops or employment opportunities should go; what they might be or look like; what community facilities should be protected and provided; and which green spaces should be protected and improved.

### How can you get involved?

A Steering Group made up of local residents is already established, this will lead on producing the Neighbourhood Plan and is an open group that anyone who lives in the area can join, at any time.

No previous experience or specific skills are required, just a passion for our area and being comfortable speaking with other local residents to discuss the future of our villages. ## Local Green Spaces Further Information

The Local Green Space designation is a way to protect green areas or open spaces against development where they are of particular importance to local communities. Local Green Space designations are made for use in Local Plans or Neighbourhood Plans. These plans can identify on a map ('designate') green areas for special protection. Once designated, Local Green Spaces receive protection consistent with national Green Belt policy. This note outlines the National policy position for Local Green Spaces;

### National Planning Policy Framework (NPPF)

The NPPF states the following Chapters:

"76- Local communities through local and neighbourhood plans should be able to identify for special protection green areas of particular importance to them. By designating land as Local Green Space local communities will be able to rule out new development other than in very special circumstances. Identifying land as Local Green Space should therefore be consistent with the local planning of sustainable development and complement investment in sufficient homes, jobs and other essential services. Local Green Spaces should only be designated when a plan is prepared or reviewed and be capable of enduring beyond the end of the plan period."

"77 -The Local Green Space designation will not be appropriate for most green areas or open space. The designation should only be used:

- where the green space is in reasonably close proximity to the community it serves;
- where the green area is demonstrably special to a local community and holds a particular local significance, for example because of its beauty, historic significance, recreational value (including as a playing field), tranquillity or richness of its wildlife; and
- where the green area concerned is local in character and is not an extensive tract of land. 78 Local policy for managing development within a Local Green Space should be consistent with policy for Green Belts."

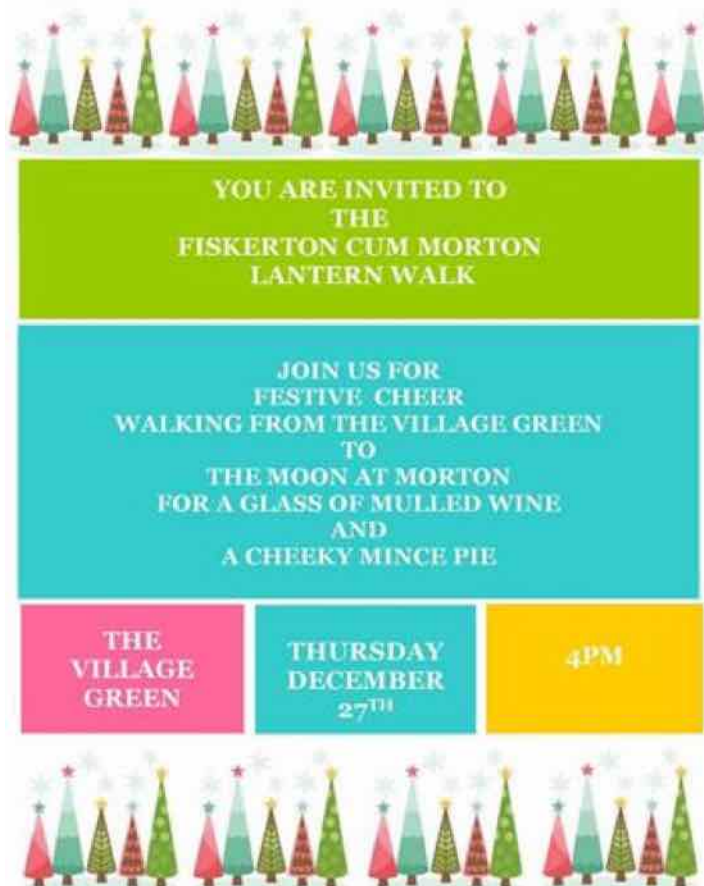

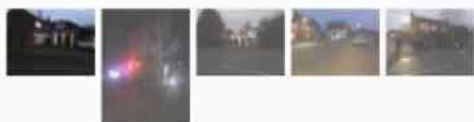

We have considered the comments very carefully and as a result, made several changes to the Plan, some of which are significant including:

- Reducing the extent of the Village Envelope/ Built up areas in both villages so they are much closer to their 1999 designation
- Removing any reference to the footpath in the Park Field and the Park Field itself from the Green Infrastructure Policy.

We are also meeting with Newark & Sherwood District Council (NSDC) this Tuesday to review the draft plan in preparation for the next stage and some further changes may be made.

<b>The Vision</b>	(1) Concerns regarding the scale of residential development in the villages	(1) The Vision, in its current form, supports only limited and organic level of growth within the villages, to meet the future needs of the community, in line with the results of the Visioning event held on 19 <sup>th</sup> June 2018.
<b>The Objectives</b>	(1) Concerns regarding residential development that meets the needs of a diverse population within the village boundaries (objective 3 and 4) (2) Concerns regarding the expansion of footpaths (objective 7)	(1) Objectives 3 and 4, in their current form, support only limited and organic growth within the villages' boundaries, to meet the current and future needs of the community, in line with the results of the Vision event held on 19 <sup>th</sup> June 2018. (2) Objective 7 will be reworded to read "Preserve and maintain the existing network of footpaths...", rather than "Preserve and expand..."
<b>Policy 1: Residential Development</b>	(1) Concerns regarding the methodology used to define the Fiskerton and Morton main built up areas boundary (2) Fiskerton and Morton main built up areas boundaries need to be tighter (3) Farmyard and Farm sheds have been added within the boundary (4) Built-up boundary should be in line with the 1999 village boundary (6) Size and quality of maps	(1) Through further conversation with Newark and Sherwood District Council, a new methodology to define the main built up area has been proposed. The methodology aligns the main built up areas to the 1999 boundaries as tightly as possible, and expands it only to acknowledge the existence of continuous built frontages that extend beyond the original 1999 boundary. This new methodology is believed to be more in line with the vision and objective, supporting limited development within a built up area tightly drawn around the villages, and consistent with the provisions of the NSDC Amended Core Strategy. As a result, the new proposed boundary for Morton aligns exactly with the 1999 boundaries, and the Fiskerton boundary aligns mostly with the 1999 boundary, extending it solely on Claypit Lane and Gravelly Lane (please refer to the Policy Maps 1.1 and 1.2) (2) Better quality maps will be included in the final Neighbourhood Plan

<b>Policy 2: Affordable Housing</b>	(1) Questions regarding how need is assessed (2) Consider the needs of young families, and elderly people willing to downsize.	(1) Housing need assessments are standard evidence-based documents aimed at understanding the need for affordable housing in a specific area at a specific point in time. Policy 2 ensures that such assessments will pay particular attention to the needs of young families and elderly people.
<b>Policy 3: Local Connection Criteria</b>	(1) Questions regarding the ability to enforce such restrictions (2) Concerns regarding the opportunity to achieve a diversity of residents	(1) The Policy is in line with other similar policies contained in Neighbourhood Plans approved in Newark and Sherwood, so once "made" by NSDC the policy will be enforceable (2) The policy does not completely prevent applicants from outside the area from accessing affordable housing in the villages, but it gives priority to people with some connection with the Parish.
<b>Policy 4: Local Employment</b>	(1) Concern that Point 3 of Policy 4 will allow residential development in the countryside as long as the owners work from home.	(1) Point 3 of Policy 4, in its current form, will not allow residential development in the countryside, as Policy 1 will still apply, supporting residential development only within the village boundaries.
<b>Policy 5: Character and Design</b>	(1) Concern that the requirement of the policy will not be respected by developers.	(1) Once "made" by NSDC, the criteria in the policy will become material considerations and will be used to assess planning applications.
<b>Policy 6: Views and Vista</b>	(1) Not enough views in Morton (2) Too many views in Fiskerton (3) Quality of maps (4) Concern regarding views on private houses	(1) Following discussion with Newark and Sherwood District Council, it was established that rationalisation and further work is needed on the Views and Vistas Assessment and Policy. 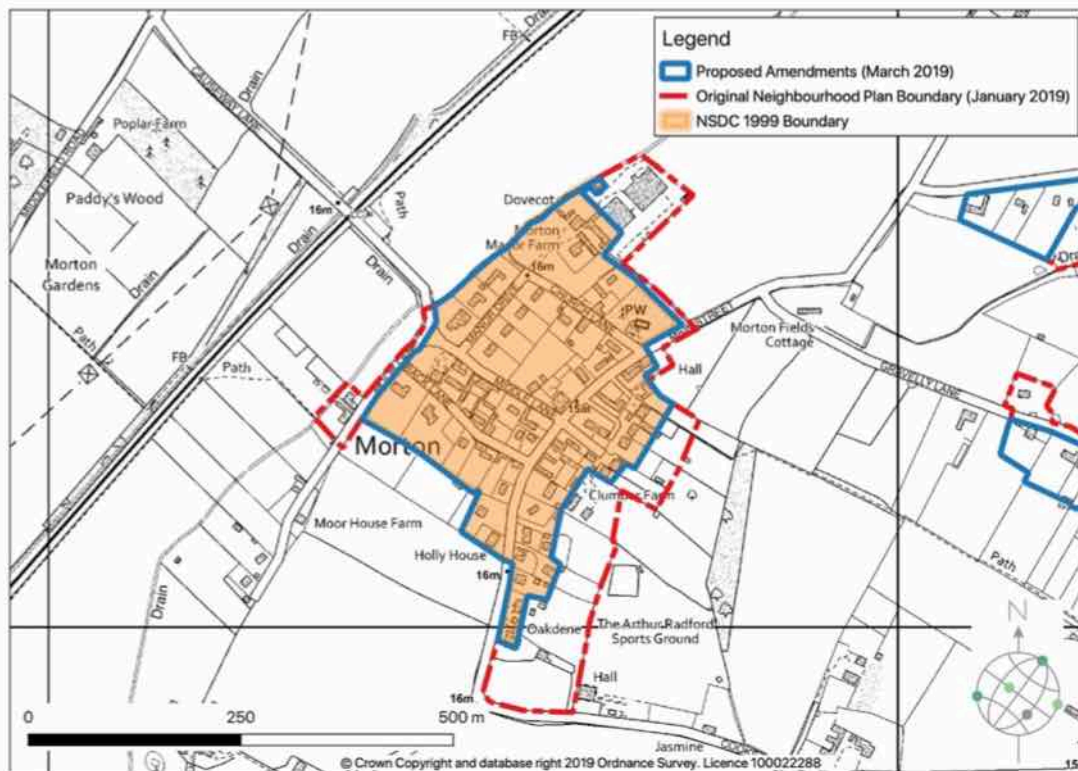
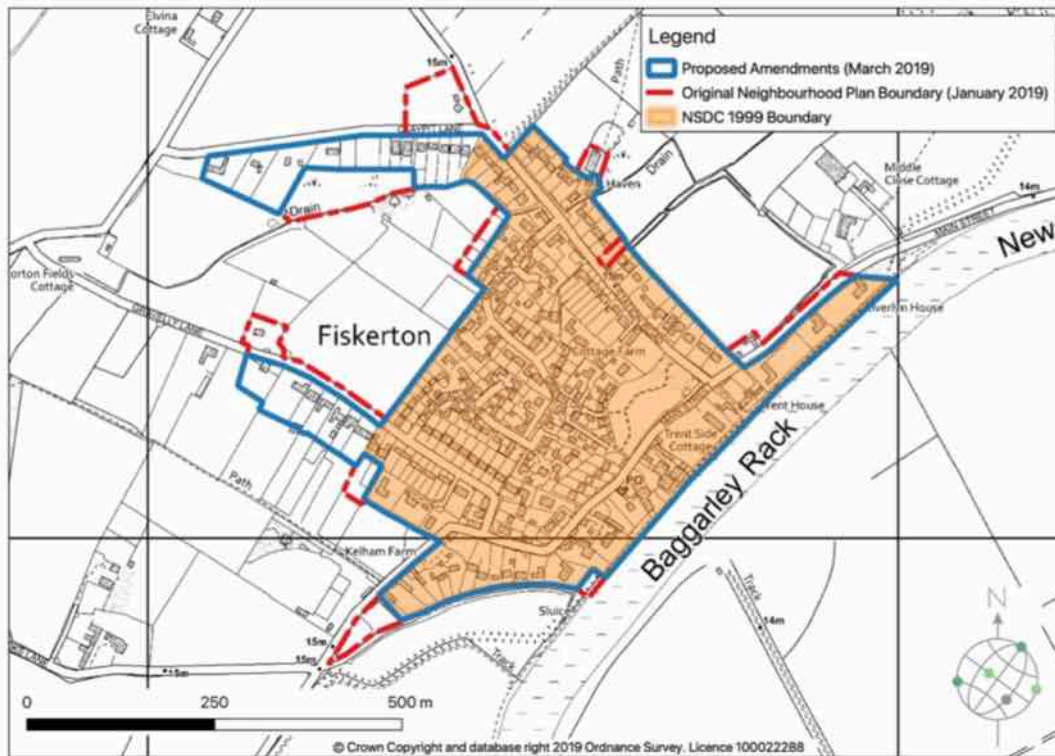

<b>Policy 8: Broadband</b>	(1) Refer specifically to full fibre broadband	(1) The Policy reads "most advanced high-speed broadband network technologies" to ensure it considers future advances in the technologies, above and beyond full fibre.
<b>Policy 9: Access to Railway Station Parking</b>	(1) General support for the policy (2) Concern that residential development outside the village boundary will be supported if it provides parking at the Station	(2) Policy 9, in its current form, will not promote residential development in the countryside, as Policy 1 will still apply, requiring residential development to occur only within the village boundaries.
<b>Policy 10: Heritage Assets</b>	(1) Concern about the limited number of heritage sites identified in Morton.	(1) The Policy will be reworded to better clarify that all Listed Buildings, Scheduled Monuments, and "Unlisted Buildings of Local Interest", as presented in the "Appraisal of the Character and Appearance of the Conservation Area" for both Fiskerton and Morton, will be protected. These include several buildings in Morton and Fiskerton. To increase clarity, such assets will be presented on the map as well.
<b>Policy 11: Local Green Space</b>	(1) Concerns about the Park Field being designated as a Local Green Space.	(1) Policy 11, in its current form, does not allocate the Park Field as a Local Green Space. The Local Green Space Assessment does not assess the Park Field as a Local Green Space, although a previous reference to it was still present in the Conclusion section and it has now been removed.
<b>Policy 12 Green Infrastructure</b>	(1) Concerns about the Park Field being singled out for inclusion in the Green Infrastructure policy (2) Concerns about paddocks in agricultural use being identified as Green Infrastructures.	(1) The Policy wording will be amended to refer more generally to the network of footpaths, ditches and dykes, grass verges, trees and hedgerows, which fall into the definition of Green Infrastructure used in the NPPF and NSDC Amended Core Strategy. Reference to agricultural land will be excluded from the Policy. Reference to the Park Field will be removed from the Policy.

<b>Policy 13: Flood Risk</b>	(1) Suggestion to prohibit development in flood risk zones	(1) In conversation with NSDC, the policy wording will be amended to reflect more closely the provisions in the NSDC Amended Core Strategy.
<b>Community Aspirations</b>	A number of additional community aspirations have been proposed, including (1) Add speed limits in Morton village - 20mph. (2) Promote more discussion on how best to design additional facilities on the Village Green (3) a "Welcome to Morton" sign	(1) The Steering Group is considering the additional aspirations mentioned as part of the consultation, in particular the aspiration for a 20 miles/per hour speed limit; revision of the proposals for the Village Green; a "Welcome to Morton" sign. It should be noticed that the Community Aspirations are not policies, but rather general ideas originating from the consultation exercise, that would require further consultation and engagement with the residents were they to be implemented.
<b>Neighbourhood Profile Appraisal</b>	(1) Inaccuracies in the description of the Park Field (2) Some inaccuracies in the description of certain features to be addressed throughout the document	(1) The Steering Group will amend the document to correct factual inaccuracies.
<b>Local Green Space Assessment</b>	(1) Concern about Park Field being still mentioned in the Conclusion section of the LGS assessment (2) Correct ownership information on Fisherman's car park and Riverside Car Park	(1) Policy 11, in its current form, does not allocated the Park Field as a Local Green Space. The Local Green Space Assessment does not assess the Park Field as a Local Green Space, although a previous reference to it was still present in the Conclusion section and it has now been removed (2) The Steering Group will correct ownership information regarding the car parks.
