Proposal: Demolition of rear extension and construction of a new larger rear extension.

Decision: Remain neutral – leave to Planning Officer.

Location: Lower Farm Cottage, Speldhurst Hill, Speldhurst, Royal Tunbridge Wells,

Proposal: Listed Building Consent – Single storey rear/ side extension.

Decision: Remain neutral – leave to Conservation Officer.

Location: 7 Roopers, Speldhurst, Royal Tunbridge Wells, Kent, TN3 OQL

Proposal: Trees: Horse Chestnut – Reduce canopy by 33%

Decision: Remain neutral – leave to Tree Officer.

Location: Bluebell House, Speldhurst Road, Langton Green, Royal Tunbridge Wells, Kent

Proposal: Single storey side and rear extensions and conversion of garage to habitable use; Erection of rear roof extension with Juliette balcony; Front rooflight and fenestration alterations; Enlargement of off-street parking area to front and enlargement of patio area to rear.

Decision: Remain neutral

Comment: Concern expressed about potential loss of parking and turning space.

Location: The Herons, Broom Lane, Langton Green, Royal Tunbridge Wells, Kent

Proposal: Trees: Beech on front roadside boundary – Reduce height of left hand tree closest to drive by 3m and remove dead wood; Beech on right hand side – Remove dead section from top and thin remaining crown by 15% to balance and remove any dead wood.

Decision: Remain neutral – leave to Tree Officer.

Location: Saxons, St Marys Lane, Speldhurst, Tunbridge Wells, Kent, TN3 OPP

Proposal: Minor Material Amendment in relation to TW/14/504489/FULL (Demolition of 2 storey existing house and 1.5 storey outbuilding and construction of new 2 storey house and outbuilding) – To reduce the size of existing outbuilding while keeping same form and material construction within existing approved footprint and sited further away from existing tree (not protected) in neighbouring churchyard.

Decision: Remain neutral – leave to Planning Officer.

Location: 1 Bullingstone Cottage, Bullingstone Lane, Speldhurst, Royal Tunbridge Wells, Kent Proposal: Remove bank to front of house and provide for off road parking with retaining wall and

landscaping and gate to entrance; Construct summer house at top of garden.

Decision: Remain neutral

Comment: We remain neutral provided that the rural character of the lane is preserved.

Location: 14 Great Courtlands, Langton Green, Royal Tunbridge Wells, Kent, TN3 0AH

Proposal: Extension to existing garage and conversion to bedroom, rear extension to kitchen to create 'Day Room', extension to brick parking area. At first floor level extension to south facing dormer window and creation of new north facing window.

Decision: Remain neutral – leave to Planning Officer.

Location: 1 The Boundary, Langton Green, Royal Tunbridge Wells, Kent, TN3 0YA

Proposal: Tree: (G1) 3x Birch – Reduce the tallest tree by approx. 6 metres and the other two to the same

height, Reduce lateral branches by 2 metres. Decision: Remain neutral – leave to Tree Officer.

Location: 5 Dornden Drive, Langton Green, Royal Tunbridge Wells, Kent, TN3 0AA

Proposal: Demolition of existing garage and outbuildings with single story extensions to east and west of

existing building.

Decision: Remain neutral – leave to Planning Officer.

Location: Holmewood House School, Barrow Lane, Langton Green, Royal Tunbridge Wells, Kent, TN3 0EB Proposal: Trees: T6 (Oak besides Groundsman's building inc deadwood and canopy overhanging shed); T4 (Oak nearest drive besides groundsman's building, remove deadwood); T5 (Robinia next to Holm Oak, dismantle); T51 (Oak to left of gate into astro, remove deadwood); G24 (2x Oaks either side of path leading down to astro, remove deadwood and the low, split, decayed bough). Other proposed work: Oak tree beside crossing to the nursery, thin by 15% and clean out deadwood; Also general treework for deadwooding and safety.

Decision: Remain neutral – leave to Tree Officer.

Location: 5 Holmewood Ridge, Langton Green, Royal Tunbridge Wells, Kent, TN3 0BN

Proposal: Lift the crown by 5m of all the trees around the boundary of the back garden – to allow more

light into the flowerbeds and hedges below. Decision: Remain neutral – leave to Tree Officer.

Location: Land South-East of Garfield Langton Road, Langton Green, Royal Tunbridge Wells, Kent Proposal: Removal of existing garage and derelict building and erection of 1 no. mews house with associated parking.

Decision: Remain neutral
