8.1 Liverton Hill

Blue road narrows sign is in Hammerton's field –Highways will deal with this.

Martin Round joined the meeting at 7.50pm, suggested reporting problems to JTB. A petition of 100 signatures would automatically go before the JTB at its February meeting.
