

MINUTES FOR THE MEETING OF THE MARDEN PARISH COUNCIL PLANNING COMMITTEE ON 5TH JUNE 2018 HELD IN THE PARISH MEETING ROOM, GOUDHURST ROAD, MARDEN COMMENCING AT 7.30 PM

- *015/18* **PRESENT:** Cllrs Brown, Mannington, Newton, Stevens, Tippen and Turner were in attendance. The Clerk and one member of the public were also present.
- *016/18* **APOLOGIES:** Cllrs Adam and Robertson together with the Assistant Clerk had given their apologies prior to the meeting.
- 017/18 APPROVAL OF PREVIOUS PLANNING COMMITTEE MINUTES: Agreement of the minutes of the previous meeting held on 22nd May 2018 were deferred to the next meeting as the Clerk had not been able to print off a final version due to internet problems.
- 018/18 **DECLARATIONS OF INTEREST:** There were no declarations of interest.
- 019/18 **GRANTING OF DISPENSATION:** There were no requests for dispensation

020/18 IDENTIFICATION OF ITEMS INVOLVING PUBLIC SPEAKING:

One member of public wished to speak regarding concerns of the planning application for Highwood Green in respect of the allotment site. It was therefore agreed by all ClIrs to allow the resident to speak before the remainder of the agenda.

The meeting was adjourned to allow the member of the public to speak.

The concern raised was that following several conversations which the resident had had with Redrow it transpires that the allotments would not be provided for residents but another use was being planned but this had not been divulged. Borough Councillor Burton was aware of this situation and requested that the resident email him with the details following which he would then speak with Rob Jarman at Maidstone Borough Council.

The Clerk was asked to provide a timeline for Cllr Burton in respect of this application. Cllrs also asked for a list of the conditions from major developments to be provided so that these can be discussed in more detail at a future meeting.

After viewing the amendments and following a detailed discussion Cllrs noted the very slight amendment to the Apartment Block 1 and were extremely disappointed that the

previous concerns from Marden Parish Council had not been addressed particularly in regard to the emergency access.

(b) 18/502293/FULL – Gravel Pit Farm, Goudhurst Road, Marden Conversion of hop picking hut into 2 holiday units and change of use of land for the erection of 2 glamping units

Cllrs discussed the application and recommended approval however wished to see a condition that these are holiday lets only. Cllrs also wished noted that there were two PROWS across, or near, to the area in question.

(c) 18/501943/FULL – Unit D3, Pattenden Lane

Change of use of part existing building to provide additional office accommodation The Clerk had contacted Maidstone Borough Council asking for further information however a response had been received that due to the nature of the proposal there was no requirement for a Design & Access Statement or Planning Statement, KCC Highways had been able to assess the impact without a Travel Plan or car parking layout therefore the Planning Officer stated that there was no justification to request this information prior to a decision being made although it could be considered by way of a planning condition.

Cllrs therefore noted but made no further comment.
