# **BRANDON TOWN COUNCIL**

Minutes of the Full Brandon Town Council Meeting Held on 5 September 2016 In the Council Chamber, The Old School House, Market Hill, Brandon at 7.00pm.

1. APOLOGIES FOR ABSENCE and approval of reasons tendered.

**2. DECLARATIONS OF INTEREST** and additions to Members Register of Interests. None.

## **3. PUBLIC FORUM**

Matters raised included a request for an update relating to the new cemetery (negotiations are ongoing but still confidential); the imminent closure of the Brandon Day Care Centre (considered by Orbit Housing to be unviable due to lack of persons using the facility); when are the new trees to be planted in The Avenue? (the principal reason being staff shortages); the resurfacing of Green Road (tarmac and chippings only); bottom end of London Road just gritted and not repaired (European money used); a paper was circulated relating to the maintenance of the trees within the cemetery.

7. TO RECEIVE REPORTS from County and District Councillors, Community Group Representatives. Contents of Cllr. P Ridgwell's written report were noted. Additional points included The Nine Stiles Walk and lack of participants (suggested the name of the walk ought to be changed next year); level crossing barrier failure (impeding an emergency vehicle getting through from Weeting). Cllr. G Hughes gave a verbal report in which he stated he had received a telephone call from Suffolk Police asking whether the town council would be willing to share the cost of a PCSO with Centre Parcs. Further details to be forwarded to GH and perhaps an agenda item for the next meeting? An update from Cllr. Lukaniuk regarding his part in looking after acquired lost property. Cllr. G Hughes pointed out, on the advice of the Police, that Cllr. Lukaniuk was putting himself at risk carrying out this task. An alternative scheme is in the pipe line. Cllr. R Silvester said he has arranged to meet with the SCC Engineer to bring to her attention several Highway issues in Brandon – primarily The Lode, replacement bollards on Market Hill and the hole on Green Road.

The Chairman reminded all councillors that any matters discussed in the confidential section of the meeting should remain confidential and should not be recorded by individual councillors. Cllr. N Vant asked what bans councillors recording confidential meetings to which they are entitled to know about. In response, Cllr. R Silvester said his understanding is, if councillors are recording the meeting for their only personal use, then they have to be present at the meeting. Once left they are entitled only to the official recording.

Cllr. N Vant further commented on a document relating to this agenda item, in which he was accused of 'surreptitiously concealing a recording device under some papers, switched on.' #### 13. CEMETERY TREES Resolution Record No. BTC/37/05/Sept/16 CARRIED:

Discussion followed regarding whether our town keepers, or an outside contractor should carry out the maintenance of the trees. Specialist training courses for our staff to be investigated (Health & Safety at Work Act 1974).

### 14. BRANDON DAY CARE CENTRE

Based on only eleven residents, on average, using the facility and the caterers pulling out because of low numbers, Orbit Housing has made the decision to close the Brandon Day Care Centre on the 30<sup>th</sup> September 2016. With no prior warning and a very short timescale before closure, Cllr. R Silvester said he will be speaking to the Leader of Suffolk County Council, Colin Noble with the objective of securing, if possible, additional funding for the Centre.
