In order to give reassurance to the various organisations that the existing councils currently fund (including museums and arts organisations) a report will be considered which recommends that funding arrangements are rolled forward for another year. The only exception to this is the £6,000 annual grant provided to each of five town partnerships in West Dorset. These grants are not provided elsewhere in Dorset and so it was considered inappropriate to continue with them in one area. These partnerships have been informed of the proposals. If agreed, this would ensure that the funding which voluntary and community groups currently receive will continue next year. Unfortunately, neither organisation have been able to provide a representative at this time. In light of this, I would propose to postpone this meeting and suggest that future meetings are held alongside the HE arranged dates, rather than meet now with limited progress to discuss. In the meantime, my colleague Coralie McGown will shortly provide you with a briefing note outlining the findings of the draft WDDC 2017 Annual Status Review. Please note that as this relates to a draft report which has yet to be validated by DEFRA, the content of the briefing note must not be put in the public domain at this time. Coralie will be in contact with HE regarding the dates of planned meetings with CPC and I shall of course notify you when it is possible to arrange a meeting with HE in order that you may then have the opportunity to discuss these issues in more detail. Jacobs provide Highways England with advice on traffic modelling and so were well placed to assess the potential impacts of 'platooning' single lane traffic. They also have in house air quality expertise.</p> <p>We met with Dorset County highways and West Dorset District Council air quality experts at the end of May to agree the brief and work to be done and discuss information sources and issues.</p> <p>Jacobs commenced work on the study in mid-June. We are currently working with Jacobs to finalise the report, which will not be done until early September. I'm sorry for the delay, but with the summer holiday season it's not been possible to complete this sooner. Also, as you might recall we are doing the same bit of work in Tideford on the A38 as we are doing in Chideock, which includes additional people.</p> <p>The basic terms of reference were as follows:                      "The feasibility project for both communities will consist of 2 key elements:                      1. Data collection (traffic &amp; composition and air quality).                      2. Assessment of single lane alternating one way traffic signal controlled flow and road re-alignment at each place."</p> <p>Whilst the report is not yet complete, I can tell you in confidence at this stage, that the advice is that the 'platooning of one way single lane traffic' is likely to cause very significant and unacceptable queueing/ journey time delay on the approaches to the village and will give rise to traffic safety issues.</p> <p>I will share a final copy of the report with you as soon as it is available, which I expect to be early September."</p>	Sent to all

It seems as if the main purpose of this meeting is to discuss air pollution, a subject of which our group has much expertise and which we have prioritised in much correspondence with yourselves and all relevant authorities. However there are still some points that councillors would like you to consider. Paragraph 6 states that once Puddletown is back up and fully operational the Eype and Turks Head checks will reduce. The Parish Council is very concerned that by reducing in particular the Turks Head checks this will miss eastbound traffic on the A35. The Council has been campaigning for many years for a HGV testing facility for eastbound traffic to the West of Chideock, and even a reduction in operations at Turks Head is considered to be a retrograde step. Defective eastbound HGV traffic through Chideock has historically been the most damaging to the village, including the major damage to a house by a defective lorry necessitating in its total demolition, plus damage to the Listed bridge, overheating causing tarmac to melt and sundry crashes. In addition, this reduction of operations at Turks Head will also reduce the ability to check for defective vehicles on three major roads namely A30, A303 and the A35.</p> <p>Therefore once Puddletown is fully operational we would urge DVSA not to reduce significantly the vehicle testing at Turks Head as it would certainly effect the well-being of several small villages along the A35, not just Chideock but also Wilmington right through to Winterbourne Abbas. Please confirm if Puddletown is now fully operational or, if there is still outstanding work to be carried out on this site, please advise the target date for when it will be fully operational.</p> <p>The Parish Council would be most interested to learn the results of recent weight checks carried out by DVSA in Dorset together with the sites involved.</p> <p>Thank you, Stuart, for your subsequent e-mail of 7 August detailing DVSA Q1 Roadside Activities A35. The Parish Council notes these figures with interest and asks if the prohibition rate versus the national average is lower for any significant reason such as type of vehicles on the road or their point of origin.</p> <p>Stuart - councillors wish you every success in your new secondment and trust that Garry Leach will be able to carry on with your initiative at Turks Head. As the section north of the existing 30mph limit on North Road is a rural lane I cannot support an extension of the 30mph here as it does not meet criteria. For 30mph limits to be most effective they should begin as close to a 'built-up' area as possible. Also, extending the speed limit would likely reduce the conspicuity of the 30mph speed limit for the predominantly residential section of North Road, something that I feel could prove detrimental to vehicle speeds. The layout of the rural section of North Road encourages vehicles speeds notably lower than the national speed limit and so I feel that the proposed speed management measures (sign and SLOWs) are the most appropriate action to take as they draw particular attention to the most prevalent potential hazard.</p> <p>We also discussed the tree canopy – Whilst I accept that the tree canopy results in dappled light and shaded areas I will not be ordering or suggesting that the tree canopy needs to be cleared, this situation is not uncommon on rural lanes and I feel that it is reasonable for drivers to adjust their behaviour accordingly. In order to remove the dappled light and shading, all trees would have to be removed and this is not something that we are able to do, nor do I think it would be welcomed, particularly by the landowners responsible for the trees.
