# 11 Peene local need housing project

The Tory Trust has asked English Rural if it may have first option to purchase the custom build plot. Councillors asked the Clerk to seek clarification of the availability for local people to purchase of rent the house built on this plot.

#### 12 Finance

The Financial Statement (Appendix D to these minutes) detailing payments made since the 27 April 2021 was reviewed and the sums detailed therein were **agreed** 

#### 13 ElecLink

The reinstatement of the playing field surface remains in dispute. The Council's agent, Sam Snart of Hobbs Parker, is continuing to discuss with Balfour Beatty/Eurotunnel the unsatisfactory restoration of the surface following the ElecLink cable laying operations. Sam Snart has also been advised of the Council's concerns over the recent hedge planting which comprises of small saplings and not semi-mature are as promised.

# 14 Tree planting

Councillors discussed Woodland Trust's 'The Queens Canopy – Plant a tree for the Jubilee' scheme and asked the Clerk to discuss with Griggs and Partners, our ground maintenance contactor, the species and location for one or two specimen trees to plant in the King George V Playing Field.

- b. Councillors agreed that the Parish Council should reimburse the Elham Valley Line Trust for the cost of hiring George's Barn for council meetings. Councillor Golding was asked to provide the necessary costs.

### 16 Telephone Box

It was agreed to utilise the telephone box as a community library. Councillor Neale offered to investigate the methods of installing suitable shelving and removal of tree root in the floor.

### 17 War Memorial Maintenance

Councillors recorded their thanks to Ray Hill for his work in maintaining the flower bed at the War Memorial and planters around the village. As in previous years, Councillors agreed to donate £50.00 to Ray to cover the cost of plants and compost.

- b. Councillor Golding has arranged a meeting with the Environment Agency to discuss access for them to carry out maintenance of the flood alleviation ditch.

# Appendix A

# Report from Susan Carey - Member for Elham Valley, Kent County Council District Councillor

Thank you for re-electing me. I received just over half the votes at the delayed election on 17 June. I've also been reappointed to my previous role as KCC's Cabinet Member for Environment and am busy catching up with both local and countywide matters.

Whilst it was disconcerting and frustrating to have the 5 week delay to the election it did mean that I had time to see many more people and the village looked lovely in the summer sunshine. It's a real privilege to represent you.

I'm sorry to report that the Department for Transport has withdrawn the temporary powers that allowed KCC to clamp illegally parked HGVs. KCC was pressing for the powers to be extended and it's deeply disappointing that the Road Haulage Industry has campaigned against this when the vast majority of clamped vehicles were foreign registered as we have very little sanction against such vehicles other than to clamp. You will see in the District Council report that we now fall back on parking fines.

There's a 2 question consultation open on a bus strategy for Kent at <u>kent.qov.uk/busfuture</u> As part of the Government's National Bus Strategy, local authorities are being invited to create an Enhanced Partnership Scheme (EPS) with bus operators. The EPS will set out shared aims and service standards with a view to improving bus services. Future government grants to support bus services will require an EPS be in place.

KCC launched a Reconnect programme for Kent's children in March and last month we put another £10m of our Government Covid Recovery funding towards it. It's about opportunities to reconnect with activities and friends and includes a free bus pass for young people in school years 6 to 13 for use between 22 July and 31 August. Residents and businesses in Kent are also being asked to volunteer their time or donate equipment or boost the funding available and they can do so at www.kent.gov.uk/reconnect The link can also be used to sign up for the Reconnect newsletter.

Several people have asked me about the Electoral Commission's proposals to increase the number of parliamentary seats in the Southeast to help equalise the number of voters in constituencies in England. The proposal involves the creation of a new seat which would see the Elham Valley area (which includes Newington) joined to part of the adjacent rural part of Ashford to create a new seat. This would not change the borders of the District Council so Newington would still be part of Folkestone & Hythe District Council not Ashford Borough Council and still part of Elham Valley for Kent County Council. #### Covid 19

#### **KCC** elections

The delayed KCC election was finally determined and I am pleased to see my friend and colleague Cllr Susan Carey returned to her seat.

# **HGV Parking**

On instructions from the DFT KCC were obliged to cease clamping illegally parked Lorries. FHDC will continue to issue FPNs on those lorries that are inappropriately parked but I feel this will not be effective enough. I have some sympathy with the drivers and believe we should continue to lobby for more parking areas within Kent.

#### **Household Waste Collections**

I wish to add my apology to that of the District Council for the abysmal performance of Veolia under their new contract. A cross party task and finish committee has been set up to hold the Contractor to account and to ensure services is returned to previous excellent levels forthwith.

### **Housing Services**

A comprehensive stock survey of Council homes began this month which will provide up to date information on all properties and inform us on the challenges of adapting them to reach Carbon zero targets.

#### Park and Ride

We are trialling a park and ride service from Jct12 on the M20 to the Harbour via Central station. Hopefully this will alleviate congestion in Folkestone and pave the way for possible further schemes. It will run at weekends and through the school summer holidays until September.

Finally, I was sorry to earn that we are losing our excellent Clerk and wish him health and happiness in the move to be near his family
