7/15 Planning Application – Solar farm at Cakers Lane

Councillors noted that Lightsource Renewable Energy Ltd had lodged with EHDC Planning Department a revised proposal for a solar farm at Wilsom Farm. The proposed size has been reduced from 22 Megawatts to 5 Megawatts and from 22 hectares to 11.4 hectares.

Councillors discussed their response to this revised planning application and proposed to resubmit their original response, objecting to the planning application, but with appropriate amendments to reflect the reduction in size of the proposed solar farm.

Cllrs, Blake Gaffney, Goodwyn, and Trigwell-Jones voted in favour of the above proposal. Cllr Brock abstained. The motion to object to the planning application was carried.
