

Website Update Survey

Background

Date of Survey: Sunday 5th July to Monday 27th July

Access to survey: Survey accessed digitally on Egerton Parish Council website

Promotion of survey: Next Door, Egerton Parish Council website, Egerton Village website.

Reach of survey: NextDoor 'Egerton and nearby' currently 1278 people and 'Egerton' 571 registered users

Responses:

Twenty-seven valid responses

Seven duplicates (Number 23)

One missing after analysis (Number 7)

Aims of survey:

Evaluate current usage, current satisfaction levels and importance of a range of Parish Council related topics.

Summary of results please refer to the raw data results in Appendix 1

Connection to Egerton

Of the twenty-seven valid responses the vast majority (93%) were residents, three of these responses also had businesses in Egerton. The two non-resident responses were connected to Egerton through 'social and spiritual' or 'other'.

Frequency of use

The vast majority (81%) used the website less than once a month with the remaining (19%) making 1-5 visits a month

Accessing Information

The vast majority (92%) found the information they required and only 2 respondents were unable to find the information they required. Ease of accessing information was evenly split between 'some difficulty' and 'fairly easily'.

Quality of the information

Here there is a slightly greater range with the major number of respondents (46%) rating the quality as adequate, and 31% as good or 8% very good. 15% felt the quality was poor and no responses were given for very poor.

Overall experience

Again, the range is similar to the previous responses, with the vast majority in the adequate (44%) or good (40%) option.

Comments received on improvements to the website Please refer to the raw results data (below) for all the comments received)

Some common themes are more information, more frequently and presented in a more accessible way. More specific comments related to accessing information on Parish Council meetings and activities, and some strong feelings from respondents on being able to express their views to the council. There were concerns raised about the impact of winding down the village website and maintaining a website to keep it up to date and relevant. Other comments were more related to the Council itself than the website survey. Interestingly of the 27 respondents, 16 (60%) used the comments facility on the survey, but only 13 (48%) respondents rated the importance of a comments and suggestions section on the website as 4 or 5.

Conclusion

Although it is important to be aware this survey has its limitations, it has provided a reasonable idea of current activity and current satisfaction levels and some useful comments for updating the Parish Council website. Certainly, there seems a desire for some changes to the website. I feel we can use this information to implement changes and, with further surveys, assess the impact.

It would be useful for the Council to consider how it intends to maintain and update the website moving forward, taking into account the winding down of the Village Website
