151.1 Delegated Powers (To Note)

MC/21/0070 Land South of View Road Cliffe Woods Rochester ('Simpkins')

Details pursuant to conditions 8 (ecological) and 12 (archaeological) on appeal decision APP/A2280/W/18/3202264 - Outline application with some matters reserved (appearance, landscaping, layout, and scale) for the construction of 50 retirement homes comprising a mix of 2/3 storey apartments and single storey bungalows with ancillary meeting room, gymnasium, office, parking and garaging with new vehicular access to View Road. Application is to discharge some of the conditions made on the original 'outline' application, granted on appeal. Details of appearance, landscaping and layout remain to be approved (currently refused). **No response required to the ecological and archaeological submissions.**

MC/21/0135 Land West of Town Road Cliffe Woods ME3 8JX (Esquire)

Details pursuant to condition 23 (Pill Box notice board) of planning permission MC/18/2961 -Construction of ninety-two residential dwellings comprising of thirteen 2- bedroomed, thirty-seven 3bedroomed, thirty-one 4-bedroomed, three 5-bedroomed dwellings and four 1-bedroomed and four 2bedroomed apartments (Class C3),provision of 737sqm of employment floorspace to include offices and a nursery (Classes B1 and D1) with associated access, parking, public open spaces (play area), landscaping, new vehicular/pedestrian access from Town Road, provision of a pedestrian crossing, associated drainage, pumping station and earthworks This is the detail of the notice board proposed on the Pill Box. **No response required.**

MC/21/0165 Waterlane House 4 View Road Cliffe Woods Rochester Medway ME3 8JQ

Construction of a detached dwelling with associated parking (near View Road/Town Road junction) At the time of the planning meeting there were no details on the Medway Planning website. Plans now available. Decision on planning consultation response required at this meeting.

After discussions Cllr Harper proposed to object to this development due to the building lines and policy framework (170B), seconded by Cllr Walton- **11 AGREE**, **2 ABSTENTION- MAJORITY DECISION**.

151.2 Applications Received since the Planning Meeting

Mockbeggar Farm-

There is a proposal from Mockbeggar Farm to relocate the caravans to an adjacent site and increase the number of caravans. The new site will not be seen from the road. After discussions, Cllr Harper proposed no comment, seconded by Cllr Walton- **12 AGREE**, **1 ABSTENTION- MAJORITY DECISION**.
