
### NEIGHBOURHOOD PLAN EXHIBITION, 24th JANUARY AT ST LUKE'S HALL.

The hall was busy all day as 438 residents came to see:

- A map of the housing sites now available.
- An account of discussions with landowners and developers.
- A summary sustainability report.
- An outline proposal for an employment site.
- The developers' proposals for their sites.

In addition there are three small sites away from the village.

The two sites shown in BLUE belong to one landowner. The four sites shown in GREEN belong to another landowner.

The boxes show the numbers of dwellings the landowners /developers are willing to consider.

At our presentations in November and in the questionnaire in July there was a strong preference for small sites, phased over the plan period. However, the small sites do not add up to the 150 dwellings required by the Borough Council. It was therefore necessary to involve the owners of the large sites.

The results of these discussions led to three 'scenarios', any of which would deliver 154 dwellings.

# SCENARIO C COMBINATION OF SITE J: W OF SAPLEY PLAYING FIELD AND SITE K: W OF POND CLOSE 4 SMALL SITES 29 154

Residents were asked to place these in rank order of their preference, with an addition choice of Scenario D, to make a different proposal. The NP Group recommended SCENARIO A. There were 384 useable responses. The results are as follows.

#### 1<sup>st</sup> preference votes

SCENARIO A 148 39% SCENARIO B 118 31% SCENARIO C 67 17% SCENARIO D 51 13% 384 100%

#### **SCENARIO D**

Of 51 votes,

40 rejected any use of small sites (10%)

23 proposed all 150 dwellings on site F

6 proposed all 150 dwellings on Site F OR on Sites J&K.

10 proposed 150 dwellings on the Great North Field\*

9 proposed various other combinations some of which did not add up to 150.

\*This was not on offer because the developer (Dandara) proposes 275 dwellings which is 78% more than the NP requires; is not willing to phase the development; has not been willing to work with us within a Neighbourhood Plan and has announced the intention to make a planning application ahead of the NP, thereby excluding themselves from the process.
