5 Planning

DM/20/02624/FPA – West of Woodcock Hall – conversion of agricultural building to form residential dwelling – no objections

DM/20/02714/FPA - ADDRESS Single and two storey extension - no objections

DM/20/02817/FPA – Green Fell View – erection of porch to front elevation and garden room to rear. Cllr Hughes raised a concern with the porch in a conservation area where the only porches facing Front Street and Low Road are on the church, the former Methodist chapel and the school. Woodcock Hall has got a porch, but it is not on the same alignment as the other houses. The school has the only porch on the North side of Front Street and to add one to green Fell View would be anomalous in the street scene and stand out quite starkly. I think there is also an issue that, if it were to be approved, others might want to put one on their houses too. I imagine the conservation advice will be to refuse it, as it is inconsistent with the aims of the Conservation Area. We are waiting to see what the Conservation/Heritage officer says before we comment

DM/20/03199/FPA Former Department of Transport Storage Depot – 4 new dwellings We would like to emphasize the need for an appraisal of the village's electric supply to ensure its resilient in the light of the new housing and upgrades and alterations in the existing infrastructure.

DM/20/03385/FPA The Old Armoury – Extension of existing structure to form office and facilities block on CL and campsite – no objections

6. Correspondence

A66 Highways England – we have received a pack showing areas where surveys are required and amounts of compensation that we can claim. Clerk has given permission in writing for Ardent to access the land. Several parishioners have written/spoken to Highways England and they have been told that they are rethinking the turn off at Stone Bridge. Clerk to confirm that this is the case. Clerk received an e-mail today stating that the surveyors have confirmed their intent to revisit the vantage points and transects to assess wintering bird habitats as outlined previously from W/C 14th December 2020. These repeat visits are scheduled to take place through to March 2021, on a weekly basis, and will be conducted by Ecus Limited (a sub-contractor of Amey Plc).

It is National Tree week which runs until Sunday, 6th December and is the UK's largest annual tree celebration. Due to the coronavirus they have extended the application period until February. Maximum Grant £150. Send info to Cllr White to see if he will apply for this.

7. Cemetery & Village maintenance

Cllr Carlisle has cut back the yew trees around 11 graves and cut an avenue at the bottom section. The elder has also been cut back. Cllr Hughes thanked Cllr Carlisle for all his effects. Cllr Carlisle feels that the yew trees need professional work when the weather is better.

8 Allotments

All of the bills have been sent out, I am just waiting for the odd payment to come through. One of the allotment holders have asked for hard core for the boggy entrance to the lower plots. Clerk to reply "we will take a look at the site and consider our options bearing in mind that it is not our land.

9 Play Park

Our DCC inspection report has brought our attention to some rotting timber on the adventure trail, it has been marked as low risk. We will replace the timber when the weather improves. Cllr Redfern has put some Cupinol on it for now.

DCC have confirmed that the play park can stay open in the second lockdown.

Cllr Redfern is continuing with his inspections now the playpark is open.

10 Parish Paths

Cllr White has been successful with another claim for stile repairs on FP17. Cllr White has asked Craig to do the work on the stone stile next to the Annums.

11 AOB

Cllr Tipping is going to contact the Northern Power Grid regarding the lack of electrical capacity in Bowes. The transformers exploded two years ago and there are new houses going up and this will be a further drain.

We will re- examine the possibility of a 20 mile an hour zone again after being previously rebuffed from DCC
