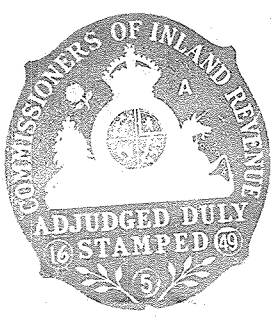

This Conveyance

is made the Twenty second day of March One thousand nine hundred and forty nine **Between** Mary Louisa Sorby of The Hall Thorpe Salvin in the County of York Widow (hereinafter called the Donor) of the one part and Thorpe Salvin Parish Council in the West Riding of the County of York (hereinafter called the Council) of the other part **Whereas:-**

- (1) The Donor is seized of the property hereinafter described in unincumbered fee simple in possession
- (2) The Donor is desirous of making a free gift of the said property to the Council in order that it may be maintained and managed by the Council for the purposes of cricket or other games and recreations and generally for the recreation of persons of all ages

Now this Deed witnesseth as follows:-

1. In pursuance of the said desire and agreement the Donor hereby conveys unto the Council **ALL** that piece of land containing two decimal point one five three acres situate in the Parish of Thorpe Salvin in the West Riding of the County of York more particularly described in the plan drawn hereon and thereon coloured pink **Except and reserved as mentioned in the Schedule hereto to hold the same unto the Council in fee simple for the purposes of cricket or other games and recreations and generally for the recreation of persons of all ages**

2. The property shall be known as "the Sorby Recreation Field"

3. The Council hereby accept the said property and hereby covenant with the Donor to manage and use the said property in perpetuity as aforesaid and not to use the same for any purpose other than as hereinbefore specified

4. It is hereby declared that any rules and regulations which the Council may make for the use and management of the said property may from time to time be varied by the Council as and when occasion may require

5. The Donor hereby acknowledges the right of the Council to the production of a conveyance dated the twenty sixth day of July One thousand nine hundred and twenty one made between The Most Noble George Godolphin Sixth Duke of Leeds of the one part and the Donor of the other part and the Power of Attorney hereinafter mentioned and to delivery of copies thereof

6. It is hereby certified that the transaction hereby effected does not form part of a larger transaction or of a series of transactions in respect of which the amount or value or the aggregate amount or value of the property conveyed or transferred exceeds five hundred pounds
