

Burial Fees (Effective From 27 June 2023)

There will be no out of rotation burials or pre-purchases in the new section.

For the purchase of a plot at the time of interment the deceased must have been a current or recent resident of Newington 15 consecutive years in the past 25 years to be eligible for parishioner rates for both the plot and interment.

Residency can be proved by inclusion on the Parish Electoral Roll, or a recent utilities bill.

These fees make a valuable contribution towards the upkeep of the Cemetery.

The fees for under 18 years old can be claimed from the Government's Children's Funeral Fund, please ask your Funeral Director for details.
