<u>Comments:</u> The Committee felt this would be a loss of amenity without true justification. The lack of stability of the tree and with little risk to adjoining properties and with no evident danger to people or properties the application should be refused specifically as remedial works could be undertaken to the tree rather than its removal if truly deemed necessary.

## 7. Update from Neighbourhood Plan meeting held on 22 July 2015

Cllr Jessop reported that the Inaugural Steering Group meeting had taken place. The next meeting will consider the Terms of Reference under which the Group will work, the officers, the vision for the Plan and the brief for the appointment of consultants. Cllr Jessop confirmed that a meeting to discuss the proposal to share a Traffic Warden with Rye will take place on 3 August with Katy Bourne, Sussex Police and Crime Commissioner.

Cllr Howell highlighted some fences that appear to have been erected closer to the highway than the one metre policy. A recent example of this was Telham Hill House, Telham Lane.
