Minutes of the Meeting of Langrish Parish Council held at The Cow Shed, Ramsdean on

Monday 8 September 2025 at 7:30pm

Present: Councillors Debbie Luff (Chair), Roger Hetherington (Vice Chair) and Robert Bewes Sam Marchant (Clerk).

1 member of the public.

1. Apologies for absence

Apologies for absence were received from Cllr Talbot-Ponsonby, Cllr Blackwell, Cllr Walder and Cllr Mocatta (District & County Councillor).

2. Declaration of Interests: Cllrs were asked to declare any pecuniary interests.

No declarations were made.

3. Minutes for review & approval:

a) Annual Parish Meeting held on Wednesday 14 May 2025

The Chair asked Councillors to consider whether the minutes were a true record of the meeting. Councillors who had attended the meeting confirmed that they were accurate, the minutes were approved as read and signed as a true and correct record.

b) Meeting held on Monday 21 July 2025

The Chair asked Councillors to consider whether the minutes were a true record of the meeting. Councillors who had attended the meeting confirmed that they were accurate, the minutes were approved as read and signed as a true and correct record.

4. Open Forum: Members of the Public were invited to comment.

A resident raised concerns following a recent road traffic accident near his property, noting wider issues of speeding and inadequate road signage.

Key points discussed included:

Existing road signage is outdated; a replacement or repair may be required.

A new Speed Indicator sign, costs were believed to be in the region of £2,500. The Chair noted possible grants and the requirement for volunteer support.

The accident in question was considered to be more related to poor road markings than speed; the bend itself naturally reduces vehicle speed.

Concerns were raised about driver misjudgement, overtaking on the bend, and the frequency of dead animals on the road.

Councillors agreed that the matter is primarily a highways issue, with potential options including reducing the speed limit from 40mph to 30mph, reinstating cats' eyes, and replacing missing chevrons.

It was suggested that residents report road issues directly via the Hampshire County Council website or the "OurHants" app.

The Parish Council confirmed its support in principle and agreed to follow up with Cllr Mocatta and Hampshire Highways.

Action: Clerk to liaise with Cllr Mocatta and report back. Cllr Blackwell to investigate costs for pole-mounted speed devices.

6. Finance & Admin Matters:

a) Finance summary Actuals vs Budget & list of Payments and Receipts report (15 July – 1 September 2025)

The RFO presented the financial report, which was unanimously approved by Councillors. (Appendix A)

b) Project ideas to include in budget planning for 2026-2027: to note

Councillors noted including a Speed Sign.

c) CiLCA Clerk Training: to approve

Approval for the Clerk to undertake CiLCA training was noted.

7. Matters Arising

a) Feedback on Unitary Authority Consultation on 7th August (DL)

The Chair reported that in general she had felt that there had been disappointment from East Hampshire delegates that EHDC were to be included with Basingstoke and Dean, Hart, Rushmore and Winchester. She had asked the question as to why this option had been chosen by executives over an alliance with Test Valley, Winchester, and EHDC and had been informed that the decision had been made purely based on finances and not the compatibility of District Councils which were able to work together with common interest. The proposed option would look to save money through Council Taxes and CIL money from the area to support the more densely populated areas of North Hampshire and Winchester and to finance increasing resources needed for Community care, Special Educational Needs and children in care.

- b) Community Grants: to note current grants open for application
 An Orchard grant from SDNP would be investigated for potential replacement trees at the Langrish Meadow orchard due to suffering losses over the summer.
- c) War Memorial: to review public response to consultation.

 The majority of residents supported a project on the village green. The Parish Council was unable to fund at present, and uncertainty remained around the future of the church. The matter would remain under review.
- d) Remembrance Sunday: to note plans

Arrangements to proceed as usual. The Parish Council would invite Stroud Parish Council to participate, order a wreath, and ensure a representative would be available to lay it.

e) Speeding and safety issues A272: to note actions

The matter had discussed during the Open Forum to be revisited at the November meeting. Actions to include contacting Hampshire Highways regarding gateways. Speed Indicator sign and painting of the bus cages.

f) River Rother Communities and Parishes Event 7th October Noted.

8. Reports and Updates

a) Bench refurbishment (CW)

Councillors confirmed the quote for works was satisfactory.

b) Langrish Meadow / Community Orchard (IB)

A report had been circulated from Cllr Blackwell. While some trees had survived, many had not. Further grants were to be investigated.

c) Footpaths and Rights of Way (RB)

Cllr Bewes reported progress on installing additional kissing gates with Countryside Services supplying gates and the Parish Council undertaking installation.

With regard to BOATs the Chair reported that she had been disappointed to learn, particularly after assurances from Cllr Robert Mocatta at the last Langrish Parish Council meeting. that the new BOP was not passed at the last HCC Utilities meeting. From what she could gather, HCC Councillors wanted a trial period to see how the proposals in the BOP would work. This needs to be in place before the Elections next May or she feared all the work which had gone into the paper may be lost.

d) Lengthsman: to note recent works and call for jobs (RB)

Recent works had included installing a kissing gate, new jobs identified included clearing the shelter and ditch at Ham Lane.

e) Roads/Highways (IB)

Had been covered under Open Forum and due to Cllr Blackwells absence, no report available.

f) Website (RB)

Cllr Bewes planned to write an article for the Squeaker asking people to sign up to the Parish Council website, this would help with engagement of the community.

9. District and County Councillor report: to receive a report from Cllr Mocatta

A report received had been received. (Appendix B)

10. Any other business

No additional matters were raised.

Hampshire County Councillor Update September 2025

Hampshire Faces Major Funding Cuts Under Government's 'Fair' Funding Review

Essentially this takes money from rural areas in the South and passes it to urban councils, particularly those in the North and Midlands. So, despite the really great work we are doing to improve our finances the Government's transfer of funding to the cities and the north will just undo all the good we are doing. Hampshire County Council has now responded to the Government's Fair Funding Review 2.0—and we're sounding the alarm. The proposed changes to how councils are funded could leave Hampshire significantly worse off, with many councils across the county facing real-terms cuts.

What's happening? The new formula underestimates Hampshire's needs and overestimates how much we can raise through council tax. It risks deepening our financial deficit and reducing vital services.

III The numbers speak for themselves:


Hampshire County Council: funding drops from £338.9m in 2025/26 to £291.1m in 2028/29—a loss of £47.8m.

East Hampshire: down £1.3m

Eastleigh: down £1.6m Hart: down £1.4m

Test Valley: down £4.4m Winchester: down £2.1m

Even councils seeing small increases—like Fareham (+£2.1m) or Havant (+£1.3m)—won't escape the pressure, as overall resources shrink and demand grows.



Fairer service formulas that reflect real demand, especially in rural areas.

Use of actual council tax levels—not national averages—when calculating funding.

Reform of the New Homes Bonus to support infrastructure for growing communities.

A funding floor that protects councils from falling below sustainable levels, indexed to inflation and population.

Why it matters: Without urgent changes, Hampshire's councils could struggle to deliver essential services— especially for vulnerable residents. We're urging the Government to rethink and deliver a formula that's truly fair for all.
