2511/07 Report from Babraham Research Campus (BRC) representative

A lot of work has been done on the Permissive footpaths- removing poplars and subsequent woodland enhancement, this has been carried out with approval from the Forestry Commission. There have been some closures of the path and this is just temporary. Mulching and repairs to boundary fences have also been done. Ash dieback has affected some trees and these have been treated or removed, they will be replaced but the distance between them has been increased to prevent any disease spreading. High St- ivy has been removed from the flint wall.

The path along the river between the church and the Farm Drive will be levelled and woodchip laid, the kissing gates will be removed to make access easier for disabled to use. Hedge planting continues along field margins in alliance to the Countryside Stewardship scheme.

Starting on Feb 17th, surgery work will be done on Oaks and Sycamores.

The BBSRC are working with the Bush and Bennet charity on the change of covenant, a letter of comfort to allow the building of the school/hall extension to commence. Close- the Planning application has not yet been submitted; this is held by BBSRC. Chris Chapmans hours of work are changing; he informed us that he now works Tuesday to Thursdays inc.

The building work is all set to go, DeMat need permission from the Dept of Education, however work will start on the foundations to comply with the planning application which says work must start by December.

- Sec 106 money to be used in conjunction with the Babraham Village Hall charity funds to build an extension to the existing school hall for shared use between the school and community.
- Accept KWA Architects plans and their company as project managers of the proposed build
- Accept PD Doyle as the nominated builder and approve the cost of £354,000 to be paid from sec 106 and Babraham Village Hall funds combined.

From Greater Cambridge Planning:

The Draft Local Plan and associated paperwork is scheduled to be considered by South Cambridgeshire District Councils Scrutiny and Overview Committee on Thursday 6th November in advance of the Council Cabinet meeting on 25th November to approve consultation on the document over December and January.

The draft Local Plan outlines a proposal for a new community of some 6000 new homes at the junction of the A11 and A1307 Cambridge Road. I recognise that the proposal is likely to give rise to a number of questions and views both to and from, your Council.
