

### **Report of the Finance and General Purposes Committee**

### 1. APOLOGIES FOR ABSENCE

#### 2. DECLARATIONS OF INTEREST ON THE AGENDA

No disclosures or confidential items on the agenda.

#### 3. RFO REPORT

## a. Report by RFO (J Bate)

- i. Draw down for the loan of 1A High Street has been requested to cover the purchase value, LPC have funds available if there is a delay.
- ii. Bank funds currently stand at approximately £330k including the precept which is expected on the 9<sup>th</sup> April.
- iii. The sale of WPF is progressing and Section 106 monies of £20k are expected imminently.
- iv. Still working on setting up a Local Government Pension Scheme for L Westcott.
- v. Income from cemetery may be incomplete as there is no tracking of payments. **ACTION** L Westcott to update rules and protocols for burials and how payments are tracked.
- vi. Unity bank account this will be set up in two days time, we will need to notify MBC and other organisations when everything has transferred.

### b. 1A High Street

Cllr. J Britt reported that the purchasers of the flat had signed paperwork and paid the deposit.

## c. Sale of strip of land at William Pitt Field

Cllr. J Britt reported that we are waiting for notification for Thorneloe to sign the contract. This will be signed by the chairman and clerk.

### 4. UPDATE ON SECTION 106 & CIL MONIES

- a. Section 106 money from the Paddocks is due, but it needs to be allocated to a project this was agreed to go towards the Cross renovation and village signs.
- b. £12,681.73 of CIL money from Land west of the Old Goods Yard (19/505281/FULL) will be paid by 05/05/21.

#### 5. PROJECTS UPDATE

**a.** Section 104 at the Paddocks – conversations have been had with West Kent Housing and SWS regarding the sewer from the development that passes under LPC land, no one is taking ownership of it. Cllr. A Walmsley reported that a deed of Grant was agreed to allow construction of the sewer

on LPC land. Cllr. M Ballard reported that it is important that we absolve liability in case of any issues with the sewer at this point.

**ACTION** Cllr. J Britt to send deed of grant to Hallett and Co. and ask for advice on how to proceed.

#### b. The Cross

**i. Interpretation Boards** – Two quotes for the boards were discussed and it was decided to proceed with Noticeboards online.

**ACTION** Cllr. A Walmsley to inform the Thornes of agreement to quote from Noticeboards Online

**ACTION** Cllr. A Walmsley to send information on design of the boards to the Thornes

ii. Quote for Gates – Two quotes for gates received from Steve Waring.

**ACTION** L Westcott to request a drawing of the proposed gates before decision is made.

**iii. Security** – Cllr. J Britt reported that he has communicated with KCC and the PCSO regarding ideas for CCTV – real and dummy cameras. Cllr. M Michaealas has spoken to the owner of Wents Garage who use the Pilgrims Way legally for off road biking, he has expressed his concern over the illegal users.

**ACTION** Cllr. J Britt to invite Wents Garage owner to next LPC meeting.

**ACTION** Cllr. A Walmsley to contact the residents to gain their views on the use of CCTV.

# c. Headcorn Road Play Area Maintenance Plan

Cllr. M Lowe reported that MHS Homes are keen for LPC to take over maintenance of the new play area. Cllr. M Lowe's proposed plan with associated costs was circulated prior to the meeting for discussion. All agreed for Cllr. M Lowe to begin negotiations with MHS Homes.

**ACTION** Cllr. M Lowe to send proposed plan to MHS Homes.

#### e. Quote from Chris Hill

A quote from Chris Hill has been received for a new bin in Maidstone Road car park and seeding on Groom Way. Quote of £100 for the bin and location agreed. No one was clear on where the proposed seeding was for.

**ACTION** L Westcott to instruct Chris Hill to install bin and discuss proposed seeding locations.

# f. Proposed Memorial Bench at Cemetery

A request has been received from a local family for a bench at cemetery. General discussion regarding memorials made it clear that a policy is required. In this case the request was decided to not be permitted.

**ACTION** L Westcott to contact family to inform them of the decision.

**ACTION** Cllr. A Ratcliffe to produce paper on memorials at the cemetery.

# g. Grant application for planter at social club

A Grant application has been received for contribution to a planter at the social club. Concerns were raised about location of planter on a dangerous bend and adjacent to an area used by smokers.

**ACTION** L Westcott to notify Social Club that LPC cannot support this request.
