He also asked what was happening with the moles as he had patted down the hills after the last meeting. **ACTION: Clir Blagg**

Clir Jones: stated that the all the bus stops in Shireoaks have now been raised to accommodate disabled access. However the members had asked for a stop incoming from A57 at the junction of Coach Road as currently the outbound stop can be used but there is no way of getting off at this junction as there is no actual designated stop with any access, let alone disabled access. He pointed out what a waste of money it had been to do the job on the outbound side and then have to come back to do the stop on the other side. A letter is to be sent to Highways expressing this concern.

ACTION: Clerk

Clir Palmer: was concerned about rubbish dumped over the railway embankment. This was located just after Shireoaks station going towards Worksop. A letter is to be sent to Network Rail asking them to remove this. **ACTION: clerk**

He also informed the members of his intention to resign from the Parish Council as he has other commitments. He will forward a letter to the clerk stating this.

Cllr Atkinson: was again concerned about the rubbish along Spring Lane. An email will be sent to litter busters. **ACTION: Clerk**

Clir Ayton expressed concern with regards to a tree growing out of a drain on marina Drive. By lamppost 3. It was stated that's Notts CC owned this land and a letter would be sent to them asking them to remove the tree. **ACTION: Clerk**

Clir Blagg: reported that the street light at the end of Thorpe Lane is still not repaired making it very dark on the approach to the village from Thorpe Salvin.
