## 099/17 PLANNING APPLICATIONS WITHIN MARDEN PARISH

(a) **17/505395/FULL – Spencer's Field, Goudhurst Road** Residential development for 65 dwellings (Use Class C3) including affordable housing, structural planting and landscaping, levels, surface water drainage and attenuation, open space, vehicular access point via the Parsonage site and associated ancillary works -*Amendments* 

Cllrs were disappointed to see that the 2.5 storey dwellings had been retained and that they have not been moved towards the centre of the development, as previously commented by Marden Parish Council. Thus existing properties have the potential to being overlooked.

Cllrs welcomed the increase in the attenuation and storage of the surface water drainage system and it is essential that the culvert is upgraded. It is entirely appropriate that Section 106 money is allocated to The Cockpit play area, and although not stated in the letter, the Section 106 money for health care is allocated exclusively to Marden Medical Centre.

The Assistant Clerk was asked to reiterate the Cllrs previous comments in the response to Maidstone Borough Council.
