Since the last edition of Char Chat, there have been 9 crimes in Charmouth and 3 RTCs: 3 shopliftings in the village, 3 instances of domestic violence, a theft of materials from a building site, an assault at a caravan park and an attempted break-in to a garage. In the summer holidays there will be an increase in the number of visitors so please do not make yourself a target: Lock doors and windows when you go out and do not leave items in your car. Simply leaving a rucksack on the car seat makes it a target, as it could contain something valuable. During this period, there have been 3 reports of antisocial behaviour relating to "boy racers" on the A35 and Stonebarrow Lane. This is a big reduction on the number of complaints received about noisy vehicles and their driving; a result of us targeting of these drivers. The first elections for the new Police and Crime Commissioners are on 15th November. On the positive side, the seat at the bus stop in Morcombelake was made and installed with the help of the Lengthsman by retired Cllr Ken Tubb. We are very grateful to him for the work he had to put in.

New Local Plan for West Dorset. Weymouth and **Portland**

West Dorset District Council and Weymouth and Portland Borough Council have published their draft plan, which is available for consultation until 27 July.

The draft Local Plan sets out a long term planning strategy for the area up to the year 2031 and includes detailed policies and site proposals for housing, employment, leisure and infrastructure.

This is the first time that a single Local Plan has been prepared that covers both local authority areas. When adopted it will be used to assist in decision making on future planning applications.

Whilst the plan has been jointly prepared, decisions on land within the boundaries of each council area have been made by the council for that specific area.

Planning applications will continue to be determined by each council for its own area. Drop-in events have been arranged for members of the public. A comment form is available on the website at www.dorsetforyou.com/ newlocalplan/west/ weymouth.

All comments must be received by 27 July.





Good Fences make Good Neighbours

he would not have minded his words being used to of their long lives. introduce an article about hedges! The cutting back of highway hedges and trees is the responsibility of the landowner or occupier of the land on which the hedges and trees are growing. Hedges and trees should not be allowed to obstruct roads and footpaths, obscure streetlights or road signs. On bends, an overgrown hedge that obscures visibility can present a real hazard to all road users and drivers on our narrow country lanes can find themselves driving wide of an overhanging tree or bush, damaging verges and breaking up the edges of the road surface. So, please, I would ask you to manage hedges responsibly. However, at this time of year, please spare a thought for nesting birds before starting work. Nests that are either being built or in use are protected by the Wildlife ad Countryside Act 1981 and care should not be taken not to disturb the occupants.

A well maintained hedge is not only a stock-proof boundary, it is also a rich wildlife habitat and the extensive network of existing hedges gives the West Dorset landscape its distinctive patchwork appearance. The importance of hedgerows and hedgerow trees is well recognized and in the Marshwood Vale, a project is underway to encourage farmers and landowners, in the course of hedge maintenance, to leave some young trees - preferably oaks - uncut. The hope is that these will be allowed to grow up and replace those hedgerow trees now in decline. This is part of a bigger scheme to see young oaks being more to replace the old oaks which are such a familiar

Or so says the poet Robert Frost and I am sure feature here but which are now reaching the end

And that leads me neatly on to trees. Some readers will be aware that the conservation area in Whitchurch Canonicorum has been extended. A map showing who's in and who's out is displayed on the Village Hall notice board. If you are inside the conservation area, there are restrictions about what tree work you can undertake without obtaining permission from the Council. Briefly, if you wish to fell a tree and its girth at 1.5 meters from the ground exceeds 75 mm, you will need permission and if you need to do any work, other than felling, permission is required only if the girth of the tree is over

And finally, a word about Tree Preservation Orders. You will see from the illustration that the area around Whitchurch Canonicorum is dotted with protected trees and groups of trees. As yet, I have no definitive map of the whole parish but I am sure I am not the only one who has spotted a tree with a little ticket stuck half way up its trunk signalling its status! There are severe penalties if such specimens are removed or damaged so I would ask you to contact either me or the Council if you have any queries about whether a tree or group of trees is protected or not. Most of these fine old fellows have been around a lot longer than we have. They deserve our respect. Go on - hug a

The Localism Act 2011

Report of an update meeting attended by Carolyn Peck, Ivan Gollop and Debby Snook

Jo Witherden, Head of Spatial Policy and Implementation from West Dorset District Council, introduced Neighbourhood Planning. Neighbourhood Plan is a planning policy document prepared by local communities (Parish Councils). It is complementary to a Parish Plan and is voluntary, but unlike a Parish Plan, which is aspirational, a Neighbourhood Plan has statutory status. The Localism Act received royal assent on November 15th 2011.

Neighbourhood Plans can cover location of development, new housing. employment sites, design standards, permitted development rights, and must conform to the National Policy Planning Framework and the strategic policies of the Local Plan (adoption due in 2013). They must also contribute to the achievement of sustainable development and have a clear time frame. The right to nominate and buy assets of community value is

The advice from West Dorset District Council about Neighbourhood Plans is sensible. Our Parish has to ask itself what it wishes to achieve and whether having a Neighbourhood Plan is the best tool to use. If we decide that we do want one, we will have the help of a link officer from West Dorset District Council. We will have to talk to adjoining Parishes, work out what resources we need and how to obtain funding, use local expertise and have a pool of enthusiastic and committed volunteers. A local referendum must be held before a Neighbourhood Plan can be implemented.

As well as Neighbourhood Plans, the Localism Act deals with the general power of competence, (councils qualify

by meeting required criteria), predetermination, the right to challenge service providers, and the setting up of a company to trade and make a profit.

A Council is deemed eligible if two-thirds of the Council have been elected (rather than co-opted), the clerk has obtained the necessary qualification (e.g. CILCA) and undertaken the relevant training, and the Council has passed a resolution that it meets the required criteria.

All of this requires a great deal of detailed regulation and consideration. The main thrust initially has been to outline the powers. It might well seem that given the costs of even relatively small projects, the Act will have only a marginal effect on most small Parish Councils and we have to recognise that these new rights are being outlined against a background of a financially constrained context and one, which we are told, is only going to get

Simon Caundle, Monitoring Officer at North Dorset District Council, spoke about the new Code of Conduct and Standards Committees, introduced as part of the Act, and their likely effect on local and Parish Councils.

The current Code will no longer apply from 1st July 2012. All Parish Councils will need a new one, as they will not be allowed to keep the old. It must be amended or re-written. When an area's principal Council, such as a district Council, has a Code in place, the Parish Council may adopt it.

The only compulsory element of the new Code deals with Disclosable Pecuniary Interests. It is expected that a Councillor's spouse or civil partner will also have to declare any such Interests. The Parish Council's register of interests must be on its web site, if it has one, and on the principal Council office's web site.

The Localism Act sets out seven principles of ethical conduct that must be reflected in an individual Council's Code whatever else is included. These are: selflessness, integrity, objectivity, accountability, openness, honesty, and leadership. It was clear that when Mr Caundle gave his presentation that the current membership and functioning of any principal Council's Standards Committee under the new legislation was still under scrutiny and there may be some further
