0A	26/03/21	Report			PCSO Bishop	"My report is as follows; On Saturday 6th March, at approx. 4am, a member of public was driving through Chideock and saw two males in dark clothing walking along the road and into an alley. It was reported as a suspicious incident and Officers attended and searched the area, but found no trace. Whilst there is nothing to suggest this has occurred in Chideock, there have been a couple of thefts of catalytic converters from Honda vehicles, across the Bridport section over the last months or so. The last occurred in Melplash, where offenders had been heard using an angle grinder but had left before Police could be called. This is likely part of an increase in this type of theft across the Nation. Catalytic converters contain valuable materials that fetch a high scrap price. I have been advised that Honda's and other Japanese makes are often a favoured target. I do not want to panic users of these vehicles, as these incidents are not common in this area (touch wood!), but I would advise people to be vigilant, review your security and where/how you park vehicles, consider using alert methods, such as doorbell cameras/cctv with alert functions and report any suspicious activity to us on 101, at the time. If you believe a crime is in progress, call 999."

This is entirely due to the A35. Since then there has been no notable political reaction locally or nationally which is a scandal.</p> <p>2.Cllr. Coates seemed to assert that the people of Chideock voted against a Bypass. They did not. They voted FOR a Bypass using the only option open to them on the voting paper in the Parish Poll. Anyone who was at the meeting where the proposal for a bypass was skilfully reworded to include "outside Chideock", would know that at the time it sounded like a good compromise and a way out of the heat of the meeting, but on reflection and in the cold light of day, that it would actually be impossible to achieve as would the de-trunking of the strategic route to the West Country.</p>	Sent to all
19						<p>3.It is the duty of our Parish Council to give our MP a broad brief, and if one of the three is to be the A35 , then individuals should not be able to cherry pick which solutions to the problems of the A35 in Chideock they wish to be omitted.</p> <p>4.Our understanding of the history of the original Bypass campaign was that a road south of the A35 was rejected on structural and geological grounds. Why then would a Councillor suggest now that we should have " an alternative route" - we would term a "relief road" - to Seatown, while rejecting a relief road to the north of the village?</p> <p>5.The claim that a relief road would "shift the problem to somewhere else" is not justified and is never expanded upon. There would still be traffic through the village, just less of it. Congestion causes pollution.
