Section D

Achievements and performance

Summary of the main achievements of the charity during the year

During the year the use of the Recreation Ground was heavily curtailed due to the Covid rstrictions although the cricket club and football clubs were able to play a number of games without access to the closed area of the pavilion. The stoolball club made no use of the facilities in the year. The use of the excellent children's play area was also restricted during the year.

The Committee of Management is supported by representatives from a number of different clubs and organisations especially the Fletching Parish Council and the Fletching Cricket Club.

A programme of repair and remedial work has been carried out during the year. The children's play area was extensively refurbished and updated following the annual inspection from the RoSPA inspectorate. There was a detailed inspection of the pavilion electrics which resulted in a major overhaul and updating of the electrical The regular fire extinguisher check was also carried out. A large part of the post and rail fencing was also replaced.

A large grant was received (£ 2,000) from Wealden Council under the Covid loss of income grant rules. The Fletching Parish Council also made a grant of £ 1,479 to the trust towards the pavilion electrical repairs and to repair to the boundary fencing.

£7,753 is held in the Unrestricted Reserve and retained as a reserve against future general expenditure.

Funds were received by way of grants from Wealden Council and Fletching Parish Council.

Funds were used for the general maintenance and upkeep of the pavilion including the upgrading of the electrical system and the playground as described above.

During the year cash funds were held on interest bearing accounts with National Westminster Bank Plc.

The land (and buildings thereon) comprising Fletching Recreation Ground is vested in Fletching Parish Council as Custodian Trustee for all the estate therein belonging to or held in trust for the Charity. The land is current being registered with Land Registry.

Important documentation relating to the Charity is held in safekeeping by Dawson- Hart – Solicitors.

During the year the transfer of trusteeship from the previous trustees to the Fletching Parish Council successfully took place on 30th June. A management committee has been set up to manage the FRGC on a day-to-day basis and reporting into the PC . The reason for this is twofold. Firstly, to guarantee the future finance of the FRGC , and secondly, to make facilitation of development of the recreation ground and pavilion more feasible.
