Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR:

Information received from the smaller authority indicates £3,592 of cancelled cheques have been included as income in Section 2, Box 3. These items should have been netted off from the relevant expenditure rather than shown as income. Boxes 3 and 6 for the current year should therefore read £5,671 and £8,750.
