DECLARATIONS OF INTEREST

There were no declarations of interest on items on the Agenda

APPROVAL OF PREVIOUS MINUTES

The Minutes of the Extraordinary Parish Council meeting of 7th January 2008 were circulated, approved and signed as a true and correct record.

PUBLIC REPRESENTATION

The Meeting was addressed by one the Parishioners about the problems in Grafty Green caused by the volume of HGV traffic thundering through the village and apart from the obvious, properties shake when they speed past, they are also damaging the grass verges. He would like us to submit an application to the appropriate authority for the introduction of a permanent restriction on HGV's either by width or weight except for access. He had counted one HGV company who had used the road 14 times in an hour, but pointed out that the increase could be due to the Leeds road closures.

ACTION PA

LOCAL POLICING

PC Paul Kemsley introduced himself to the Parish Council and advised everyone to be very careful with any item which isn't 'nailed down' because of the recent spate of crimes in the village, such as a house sign being damaged, gates were removed and found somewhere else. He reported that he is in the process of setting up a speed check but had no definite date for when this would be carried out. With regard to the HGV problem he asked if he could be given the names of the companies who are using Headcorn Road the most, once he had this information he would have a word with the companies involved.

MATTERS ARISING from Minutes of 7th November 2007

40-30 Mile Speed Limit Changes

The clerk reported that she had written to the Director of Kent Highways pointing out that the change of speed limit had made very little or no difference at all to the speed at which vehicles drive through the village, and although the 85%ile speed showed 10.7 miles over the speed limit it would mean that the majority actually drive through Grafty Green in excess of 60mph, especially as Grafty Green is being used as a 'Rat Run' first thing in the morning and then in the evening. She had asked whether the Director could suggest anything or any measure that could be put into place to encourage drivers to slow down. A reply had been received saying that traffic calming measures would be unlikely because there had been no crashes involving personal injury in the last 3 years and perhaps an alternative would be the installation of an interactive sign, but by the sound of the letter it would take some years before this might, if ever, happen, the best suggestion would be to bring the matter of speeding to the attention of the Police so that they could take any enforcement action.

ACTION PA

30-Mile Speed Limit Signs

PA had contacted Louise Rowlands at Kent Highways about installing the missing 30mph sign, leaving the signs where they were and having the vegetation cut, she suggested that a meeting should be set up in the New Year. On 3rd January Louise Rowlands met with Kenneth Alexander, Robert Turner and the clerk to discuss the sign location at the northern end of the village. It was agreed that when the missing 30mph sign is installed it would (along with the existing sign) be moved to approximately 14meters north of the property Kimburn one each side of the road. Louise Rowlands was asked about the provision of red road surfacing with 30mph roundels and she had since provided an estimate of approximately £2000. This proposal would also include 'slow' markings on the road along Liverton Hill, where there are existing Slow signs. PA was asked to find out if the £2k estimate was for red tar at both ends of the village.

ACTION PA

Now that the speed limit change within the village had been resolved, it was suggested that following the public representation above PA was to write to the appropriate

authority and find out what could be done about a permanent restriction on HGV's driving through the village. **ACTION PA**

No. 59 Bus

Nothing much to report. As a replacement to the Post Bus Nu-Venture are running a bus on a Thursday only. Lenham PC and KCC are still working on a scheme for a Community Bus.

Potholes Woodcock Lane & Church Road

Potholes are now appearing everywhere, as well as above there are potholes along Liverton Hill and up by what was the Pig and Whistle. PA is to continue hounding Kent Highways to try to get them filled in.

The clerk reported that MBC were still waiting for information from the agent and once this had been received they would then re-consult. PA was asked to find out why it takes more than 6 months to make a decision; if it were on a 3 bedroomed house it would have been dealt with long ago.
