26/24 Election of Chairman

Cllr Stacey proposed and Cllr Porter seconded that Cllr K Curtis should be elected as Chairman: this was resolved. Cllr K Curtis signed his Acceptance of Office which was witnessed by the Proper Officer (Clerk).

27/24 Apologies

Apologies were received from Cllrs G Bailey (TVBC) and N Adams-King (TVBC, HCC)

28/24 Election of Vice-chairman

Cllr K Curtis proposed and Cllr Cross seconded that Cllr Stacey should be elected as Vice-chairman: this was resolved.

29/24 Election of Councillor with Special Responsibility for Staffing

Cllr N Curtis proposed and Cllr Porter seconded that Cllr Cross should have Special Responsibility for Staffing: this was resolved.

30/24 The minutes of the 15th April 2024 meeting were agreed and signed.

31/24 Interests

No interests were declared.

32/24 Matters Arising

- a) The decision regarding the domain name was deferred since another software supplier was in the process of becoming a domain name host.
- b) No progress has been reported regarding the footpath off Botley's Bridge: the Clerk was asked to chase this.

33/24 Planning Applications

- **a) Bowers Farm, Pound Lane** (TVBC ref: 24/00944/PDQS) the Clerk was instructed to explore the possibility of obtaining legal protection for the hedge and to cc the Environmental Officer at HCC who appeared not to have considered the proposed destruction of part of the hedge.
- **b)** The Cottage, Sherfield English Lane (TVBC ref: 24/01112/FULLS) Based on information available at the meeting it was agreed that the response should be "No objection".

34/24 Members' Reports

Cllr Porter observed that the over-hanging hedge on the west side of Sherfield English Lane had not been dealt with. The Clerk was instructed to contact HCC, reminding them that this matter had been raised last autumn.
