Numerous vehicles stopped with some driving in excess of 45mph+. Please note that The Avenue goes from a national speed limit to a 30mph zone, also the driving conditions today were wet and road users should also be taking that into account when driving.

PCSO Catterick has spent his morning conducting just under 8 miles of foot patrol around Tidworth. 🏃‍♂️

With a visit to Tidworth Town Council to discuss local issues, the patrol was used to target areas which have seen an increase in reports regarding anti social behaviour in recent days including the wooden park behind Karachi Close. Extra patrols will continue to be carried out by officers, in these areas over the coming weeks.

PCSO Catterick was later joined by PC Duggan where the pair conducted speed checks along Park Road on the A338. 5 vehicles were stopped and issued with words of advice regarding their speed. Speed checks were also conducted in Collingbourne Ducis where PC Duggan issued further words of advice to motorists regarding their speed.
