- 5. Past Subject Matters for further discussion:**
 - 5.1 [6.1] War memorial: Andrew Gist suggested a firm and sent details but the clerk's email was returned undeliverable so she will try to contact them again re: web site or phone.
 - 5.2 [6.2] Trees on the Green: it was agreed that the clerk should now contact Ed Knight as there has been answer to letters sent to the previous tree man.
 - 5.3 [6.6] Village Signs: It was agreed to pay for the sign. The clerk will contact Highways.
- 6. Clerks Report and Correspondence received:**
 - 6.1 Proclamation for Parish Councils: The Proclamation for Parish and Town Councils. This is to remember our Queen Elizabeth the Second and to acknowledge the passing of the crown to her son Charles. The Accession Council met at St James's palace to proclaim the new sovereign and cause it to be read in areas of their jurisdiction. This was proclaimed in the parish church on Friday September 16th at 5pm attended by 17 parishioners and the full council of six members plus the clerk. A copy is filed with the minutes.
