The Allington Hill and Coopers Wood & Field Community Group is a volunteer group working with the Woodland Trust to maintain and enhance Allington Hill and with Allington Parish Council to maintain and enhance Coopers Wood & Field. There is an outdoor play trail consisting of sturdy play equipment suitable for children and adults. Use of this equipment is not supervised by the Allington Hill Volunteers.
