

Minutes of the Meeting of Lenham Parish Council Held on Wednesday 4th January 2023 at 7:30pm at Lenham Community Centre

Public participation

1 member of the public asked when the WCs would be reopening, Cllr. J Britt explained that the refurbishment is subject to receiving funds from MBC CIL monies, the decision for which has been postponed. The member of the public explained that the stage is in the way when retrieving the market signs from the lock up. An update has been requested from MBC.

1 member of the public raised the issue of unauthorised vehicles using the Pilgrims Way. This has been discussed at length before. The noise from the last weekend was awful and the mess made at the Cross on 12th December caused a lot of distress to LPC and the public. The member of the public suggested the only way to stop the noise is changing the status of the Pilgrims Way from a BOAT (Byway open to all Traffic). Cllr. J Britt will write to MP, KCC Cllr. and the police.

MBC Cllr. J Sams had the following to report:

- a. The food bank in the church is working well with a lot of uptake. The £1500 donated by KCC Cllr. Shellina Prendergast is being used by volunteers to restock. Vouchers from the Co op are also being well received.
- b. Hotspot at the social club has opened, but it is early days to report on its success. The Hatch charity have donated money to the social club.
- c. Highways Issues continue to be reported regularly.
- d. Golding Homes a meeting was held with them and communication is improving.
- e. LPC Budget Cllrs. T and J Sams support the proposed LPC budget and feel it is very disproportionally unfair on LPC who have to use so much money to fight Heathlands, other parishes do not have to bear this weight.

J Bate summarised the recommendation from F&GP for a budget of £248,730 using £20,000 of reserve money resulting in a precept of £228,730. This would mean a 16% increase on the parish council precept on a band D property. The figures presented were discussed.
