## 2 Minutes of meeting held 18th November 2002

The minutes were approved and signed as a true record after one amendment concerning chevrons on Darlton Bridge that had not "gone" as stated, but had never been there (ref: Matters Arising 4c).

b) Bus Shelter

Cllr Allen reported he had now cut the hedge near the shelter. It was AGREED that Cllr Allen purchase green paint and Cllr Allen AGREED to paint the shelter in drier weather conditions.

c) Planning Appeal at Blue Bell Inn, Low Street, East Drayton

Cllr Ogle reported the Appeal was due to take place in May 2003. Discussion followed and included the possibility of enlisting the help of NALC, but this was subsequently decided against as Councillors believed the Appeal would be judged on evidence already submitted. It was noted a person had been seen using a video camera recently in the area of the Blue Bell. Cllr Jones has a procedural booklet for obtaining permission to speak to the inspector when they make a visit. It was AGREED to leave the matter until March when it should be looked at again.

## d) 89B Bus Service.

The Clerk reported she had contacted Lynn Adams, transportation project manager at Nottinghamshire County Council concerning the rumours about the bus service ending. She advised that household surveys were in hand and inspectors had been on some of the routes and that the Council was looking towards "demand responsive transport". Any change in the transport service would most probably tie in with Lincolnshire Road Car's contract coming to an end in Summer 2003.

## 9 Lytchgate

- i) Cllr Ogle advised a 7" square, water-tight capsule could be purchased for £100.00 plus VAT and would take 2-3 weeks' notice to manufacture. Items for inclusion included the Council's minutes where it was first proposed to have a lytchgate and a photograph of the previous one; 2002 and 2003 coins, the Retford Times and a national newspaper. Cllr Allen suggested the time capsule could be paid for from the contingency fund. **ACTION: Cllr Ogle** to contact Dunham School after Christmas to enable the pupils to be given a chance to contribute.
- ii) Cllr Ogle reported the first half of the grant totalling £5,738.00 and a cheque for £100 given to the chairman, bought the Lytchgate Fund bank balance to £8,850. (Total grant £14,588, plus £1,500 on completion).
- iii) Cllr Jones reported he had still not heard from the Diocese concerning the replacement of the wrought iron gates with oak gates.
- iv) Cllr Jones reported Kirk and Bills intend to start the superstructure in their works on 1<sup>st</sup> March and they would come on site in early April to erect. Application can then be made again to the Agency for extra money for the gates.

- a) Paper Recycling Bin ACTION: S Pickard to contact Bolham Lane to see if a bin on wheels could be sited on the Church Lane side of the village hall.
- b) Street light near No 1 Church Lane is out. ACTION: S Pickard
- c) Open Day for new Cricket Ground Cllr Goddard informed the Council there would be an open day on 22 June and the Parish Councillors were invited to the event which would be open for fund-raising. More details to follow.
