

Last month we were able to give money to local schools and this month we have given £180 to our church treasurer to send to the Disaster Emergency Fund for help to Turkey and Syria.



Helen Whately MP - Planning consultation can help us get housing right

Ask any Kent MP what issue - come rain or shine - fills their constituency postbag more than any other and I think they'd tell you the same thing: housing.

It's no wonder. We live in a beautiful part of the world and people want to protect it. I feel exactly the same and understand the emails objecting to new homes. But at the same time, I also get emails from people desperate to find somewhere to live that they can afford - people experiencing the consequences of the need for housing outstripping supply.

Besides from its impact on our countryside, we also know that new housing can put extra strain on our local infrastructure – like putting more traffic on our roads or making it harder to see a doctor or a dentist. This is why planning is decided locally. No one knows better what an area needs than the people living in it, and no one cares more about making sure that development goes in the right place.

As a government it's our job to look at the bigger picture, think about our long-term national housing needs and decide how we're going to meet them. It's undeniable that we have a national housing shortage. That's why in 2019 we pledged to build 300,000 new homes a year, and we weren't alone in coming to that conclusion. In fact, all the main parties made similar commitments in their manifestos.

One problem is that because of the current allocations, the scale and pace of the development expected in areas like ours – beyond the protected green belt - has been really tough to keep up with. I know how worrying that's been for local residents, and that's why along with other Kent MPs I've been fighting to get the current mandatory targets reviewed. In fact, at one stage, I met with the Housing Minister three times in a month to get our point across!

Just before Christmas we found out that we'd been successful, when the Government put forward its plans for updating the National Planning Policy Framework. Not only have ministers proposed a move away from mandatory housing targets towards advisory, but there's also tougher rules to make sure developers meet community commitments, and a renewed focus on finding more brownfield sites.

There's a consultation on these plans which gives everyone a chance to have a say. You can find the consultation on the government's website until 2nd March, or if you want to feed in after that date you can email me with your views you can at helen.whately.mp@parliament.uk

Our children and grandchildren deserve the chance to own their own home someday, and that means we do need some more homes in the South East, as well as in towns and cities across the country. But I think where possible that development should be concentrated in urban areas and, crucially, coupled with the investment in infrastructure we need.

It's so important that we hear from everyone. People who've owned their own home for decades, people who've just managed to buy, and people who desperately want to get on the housing ladder someday. Together we need to get housing right for people now, as well as for our children in the future.'

Minutes of a Meeting of the Parish Council held on Monday 23rd January 2023 at 7.30 pm in the Village Hall

Present: Cllrs B Adams; N Eastwood; R Turner
Clerk Mrs Vickie Ford

In the absence of the Parish Council Chairman, the Clerk opened the meeting at 7.30 pm

M01/01/23 Chairman

RESOLVED: in the absence of Cllr Galton, Cllr Turner to chair the meeting.

Anybody filming or recording this meeting kindly requested to declare it – none

M02/01/23 Apologies

Apologies from Cllr R Galton; Cllr S Prendergast (Kent County Council); and Cllrs M Round and Z Trzebinski (Maidstone Borough Council) were received and accepted.

Cllr Turner informed all present that Cllr Kennaird had resigned.

M03/01/23 Declarations:

Any lobbying – none declared

Any interest in items on the Agenda – Cllr Eastwood declared a personal interest in the Christmas tree.

Any changes to the register of pecuniary interests - none declared

M04/01/23 Approval of Minutes

RESOLVED: the Minutes of the meeting held on 7th November 2022 and the Minutes of the extraordinary meeting held on 28th November 2022 were taken as read, confirmed and signed as being an accurate record of the proceedings.

M05/01/23 Public Session – eleven members of public present:

- A member of the public requested an update on the installation of the kissing gates on various rights of way. They expressed particular concern regarding the unsafe condition of one stile along KH427. The Clerk explained that the Parish Council had been obliged to delay replacement of the stile it lay on the footpath as walked rather than as shown on the definitive map. The member of the public asked if landowners were insured in case of accident. Cllr Turner suggested that the Parish Council could go back to Kent County Council (KCC) and the landowner to find out if anything could be done to repair the existing stile.
- A member of the public asked if the Garden Club could use Cllr Galton's tap to water the planter on the Village Green in order to retain it. Cllr Turner asked the Clerk to include a special resolution to retain the planter on the agenda for the next Parish Council meeting.
- A member of the public asked if a kissing gate could be installed further along KH325 beyond the newly-installed gate. Cllr Turner asked the Clerk to check if a stile in the location has been identified for replacement.
- A member of the public asked if any action could be taken to repair the wall around the yew tree in Church Road. Cllr Turner stated that nothing could be done by the Parish Council as the tree and wall were on private land. Cllr Turner asked the Clerk to contact KCC with regard to the yew tree as it is subject to a Tree Preservation Order (TPO).

- The Parish Lengthsman asked if the Parish Council would like a monthly report; Members confirmed that it would. Cllr Turner confirmed that feedback (reports, problems etc) should be through the Clerk. The Lengthsman had collected 2 bags of animal offal while litter picking and asked for a black bin to be sited conveniently for the disposal of rubbish.
- A member of the public asked if the Parish Council could put up posters requesting dog walkers to pick up waste. Cllr Turner asked the Clerk to find out who would be responsible/authorised to do this.
- A member of the public raised the issue of water running down Liverton Hill. All present agreed that this was a big problem during icy weather, as had been proved recently. Cllr Kennaird had contacted KCC to find out why the road had not been gritted. The Clerk was asked to chase up with KCC.
- A member of the public raised concern regarding the speed of vehicles through Grafty Green and asked what was happening to introduce Speedwatch. Cllr Eastwood stated that the Parish Council's policy was to set up Speedwatch but not enough volunteers had come forward. The member of the public asked if it would be possible to use volunteers from neighbouring parishes. Cllr Turner asked that any volunteers contact the Clerk. Cllr Turner asked the Clerk to contact the Community Speedwatch team to ask if volunteers could be shared.
- A member of the public expressed concern regarding the three serious potholes on the Headcorn Road near Offen Farm. The potholes had been reported to KCC but had not been repaired. Cllr Turner asked the Clerk to follow up with KCC.
- A member of the public complained of intermittent water supply problems, making it difficult to have a hot shower due to safety valves. They proposed to carry out a leaflet drop to see who else was affected and then organise a meeting with South East Water. Cllr Turner asked the member of the public to notify the Clerk of any meeting. Cllr Turner asked the Clerk to raise the matter with South East Water.

M06/01/23 Maidstone Borough Council (MBC) Report

Cllr Trzebinski had submitted a written report, which Cllr Turner read aloud. The Cost of Living event had been held in Headcorn and a number of people were able to receive advice which would improve their financial position in real terms. Also, subject to Parliamentary approval, Sutton Valence would be added to the existing four parishes in the Headcorn ward, to be called Headcorn and Sutton Valence from 2024.

M07/01/23 Planning Outcomes since 7th November 2022

M08/01/23 Local Policing/Community

Police/Crime Report: It was noted that the latest information was for December and 2 crimes had been reported since 7th November 2022.

M09/01/23 Speedwatch: Due to Cllr Kennaird's resignation, no update on Speedwatch was available. **RESOLVED:** to defer discussion of an article on traffic calming for publication in the Malherbe Monthly.

M10/01/23 59 Bus

The Clerk summarised the current position regarding the service and funding: due to the withdrawal of KCC subsidies from 13th February, the service would be reducing to one return journey to Maidstone every Wednesday following the re-opening of Ulcombe Hill in mid February; enquiries were being made into the availability of funding from KCC from July 2023.

RESOLVED: to delegate authority to Cllr Eastwood, Mr John Collins (East of Maidstone Transport Group) and the Clerk to apply for a community transport grant if feasible.

M11/01/23 Litter

It was noted that Liverton Hill was badly affected by littering.

M12/01/23 Highways Improvement Plan

There were no changes to be made.

M13/01/23 Footpaths and Grafty Green Stile Replacement

The Clerk reported that no progress had been made.

M14/01/23 Councillor Reports on any External Meetings

Cllr Turner reported that he, Cllr Galton and the Clerk had attended a meeting with Mr Norman Kemp of Nu-Venture, Mr John Collins, representatives of parish councils along the 59 bus route and Headcorn Parish Council, held in Grafty Green Village Hall on 2nd December 2022. The meeting had discussed the future of the 59 service after the withdrawal of KCC subsidies.

BUDGET AND PRECEPT 2023/24

M22/01/23 Budget 2023/24

Members had before them a revised draft budget, in accordance with the recommendation of the Finance and Staffing Committee. Cllr Turner stated that the Parish Services Scheme (PSS) grant was likely to reduce to £262 in 2023/24.

RESOLVED: subject to the PSS grant being amended to £262, to adopt the 2023/24 budget as presented.

M23/01/23 Precept 2023/24

RESOLVED: in accordance with the recommendation of the Finance and Staffing Committee and the agreed budget, to set the 2023/24 precept at £7,113.

Cllr Turner thanked the Clerk for her work on the budget and explained that a Parish precept of £7,113 would result in no increase per Band D equivalent household next year.

M24/01/23 Lengthsman Contract

RESOLVED: to increase the rate paid for lengthsman's services to £14 per hour.

Grafty Gourmet

Pork, cider and apples are a great combination in cooking, for a reason. This great recipe blends both the sweet and the salty flavours together for a real winner !

SAUSAGE & CIDER CASSEROLE

1 tablespoon of sunflower oil	2 tablespoons of plain flour
8 good quality pork sausages	300ml of dry cider
200g of smoked bacon lardons	300ml of fresh chicken stock
50g of butter	8-10 fresh sage leaves, chopped
2 medium onions, chopped	1 tablespoon of wholegrain mustard
2 garlic cloves, crushed	2 small eating apples
2 small parsnips, chopped	A squeeze of lemon to serve (optional)
3 large celery sticks, chopped	
1 tablespoon of tomato purée	

1. On the hob, heat the oil in a large flameproof casserole dish (with a lid). Add the sausages and brown them all over, then transfer to a plate.
2. Add the bacon lardons to the casserole dish and fry for 5 minutes until the fat is crisp and brown. Transfer to the plate with the sausages.
3. Drain off all but 1 tablespoon of the oil from the casserole dish and add half of the butter and, when melted, add the onions and garlic. Cover and cook for 10 minutes, stirring now and then, until soft and lightly browned.
4. Take off the lid, stir in the parsnips and celery and cook for 2 minutes more. Stir in the tomato purée and flour, then gradually stir in the cider and stock and bring to the boil.
5. Return the sausages and bacon to the casserole dish, then stir in the sage and mustard. Cover and put in the oven and cook for 40 minutes.
6. When the casserole is ready, melt the remaining butter in a non-stick frying pan. Quarter, core and slice the apples into wedges. Add them to the pan and fry gently for 2-3 minutes until golden all over and just tender. Season with a little salt and pepper.
7. Remove the casserole from the oven, stir in the apples and season to taste (add a squeeze of lemon if you think it needs it). Serve with baked potatoes or mash and greens.

As regards anniversaries I have to confess to finding no anniversaries of anyone of musical significance in March 2023 so I have cheated by moving to 1st April which is the 150th anniversary of the birth of Sergei Rachmaninoff, Russian composer, pianist, and conductor (1873–1943).

Rachmaninoff is widely considered one of the finest pianists of his day and, as a composer, one of the last great representatives of Romanticism in Russian classical music. Early influences of Tchaikovsky, Rimsky-Korsakov, and other Russian composers gave way to a thoroughly personal idiom notable for its song-like melodicism,



expressiveness and rich orchestral colours. The piano is featured prominently in his compositional output and he made a point of using his skills as a performer to fully explore the expressive and technical possibilities of the instrument. Born into a musical family, he took up the piano at the age of four. Following the Russian Revolution, he and his family left Russia, and in 1918 they settled in New York City. With his primary source of income coming from performances as a pianist and a conductor, Rachmaninoff had little time to compose. Because of this, he completed just six works between 1918 and 1943, including the *Rhapsody on a Theme of Paganini*, *Symphony No. 3*, and *Symphonic Dances*. By 1942, his declining health led to his relocation to

Beverly Hills, California, and later became a US citizen a few weeks before he died of advanced melanoma in 1943.

The initial findings from the inspector, in relation to Maidstone Borough Council's review of the local plan, has been made public on the Lenham Parish Council Website.

The inspector has given MBC clearance to proceed to Stage two, however there are some significant issues which need resolving for him to find the plan overall "sound". The most significant issue, for those of us in Lenham, is that although he agreed that the proposal to develop significant housing in what is described as "the broad Lenham location" was an approach, he found the specific policy through which MBC proposed to deliver this "not sound". For it to be deemed sound there are significant pieces of work that have to be completed to the inspector's satisfaction, many of these require agreement from third parties, such as Network Rail. This is not something that will easily be addressed.

We continue to work closely with Lenham Parish Council to pool our expertise and resources available to us to robustly defend the village and its precious green space.

Our attention now turns to prepare our fighting fund for the next phase of the Local Plan Review. We need to be financially prepared to legally challenge the local plan at every opportunity. To do this, we will need financial assistance ready to move fast and at a point it could be our last opportunity to fight Heathlands becoming an allocation site in the Local plan.

We now need to ask for your help. We've resisted as much as possible asking for large sums of money. However, we are going to need in the region of £50,000 in the event that we take the plan to court.

Anyone without photo ID should apply for Voter Authority Certificate now

Maidstone Borough Council (MBC) is encouraging everyone who votes in a polling station and doesn't have photograph identification to apply now so that they can vote at the local election in May.

The Elections Act 2022 means that from May 2023 voters across Britain will need to show photo ID to be able to cast their ballot in person. Maidstone will be holding its next local election on Thursday 4 May. Anyone who is registered but does not have one of the approved types of photo ID will be able to apply to get a free Voter Authority Certificate up until 25 April.

The Council is asking anyone who doesn't have the necessary ID to apply for a Voter Authority Certificate, or arrange for a postal vote, now so that they receive it in good time.

Angela Woodhouse, Returning Officer for Maidstone Borough Council said:

The requirement for photo ID for voters when arriving at the polling station is a big change this year. We realise that there may be some residents who don't have ID that meets the requirements so we are asking them to apply for a free Voter Authority Certificate now so they can still cast their vote at a polling station.

It is really important that everyone who has the right to vote does so - as every single vote counts and we want to make sure that all our residents who are eligible can do so. If anyone doesn't have a valid form of ID, please apply now, or arrange a postal vote, in good time so that you can vote at the election on 4 May.

A wide range of photographic identification which will be acceptable at polling stations include:

- Driver's licences
- Passports
- Some concessionary travel passes
- PASS cards
- Ministry of Defence identity cards
- Photocard parking permits issued as part of the Blue Badge scheme

- Free Voter Cards, provided by local authorities

Expired photographic identification will also be accepted if the photograph is of a good enough likeness to allow polling station staff to confirm the identity of the holder.

But for Christians, our identity is located deeply in the love of Jesus. In the Len Valley Benefice our verse for the year is, "In Christ Jesus you are all children of God through faith". What does this mean? It means that by receiving the love of God we are free to be secure in whom we are. We are people who know that God loves us, warts and all. We are beloved, like the best-loved child. That means that we can be free to love others, whether the 'other' has the same inheritance, is from the same location, does the same job and so on.

None of this means that all those other things about identity are unimportant, but it does mean that deep within our being, our personality, there can be a security from which everything else flows.

It also doesn't mean that this is just 'easy'. Learning that we're loved and learning to love is a life's work. Why don't you join us? What could be a better mission in life?


