# 111.14 Traffic Calming -

Current situation- Cllr Edward Heron fully supports the idea of physical traffic calming measures in Bramshaw – we have proved that the 30 mph zone, and speedwatch do not work. He believes the County Council would be looking for partnership funding from Bramshaw of about 25% of all costs if pinch points were to be put - the first set will cost in the region of £4000-£6000 with subsequent sets being about £2000 each. There would also be a requirement for a contribution to the costs of drawing up the works by the technical department.

It was resolved that before any money is spent, the parish council needs to establish whether the residents of Bramshaw actually want physical traffic calming measures in the parish, and to this end, the Parish Council will hold an open meeting just in January so that this matter can be discussed.

<u>28 October 2014</u> – decide at pc meeting date of open meeting in January 2015 and format of meeting.

Decide who is taking lead on project and associated support roles.

November 2014 – discuss financial implications and need for including an allowance in precept for possibility of the works being undertaken. Start advertising meeting.

December 2014 - Continue promoting meeting and ensure all publicity materials, locations etc are prepared.

January 2015 - Hold meeting.
