Clerk updated on recent correspondence received from NYCC Highways. Station Lane had been completed – however problems with road surface water drainage had been discovered during works that necessitated Yorkshire Water investigating SW drains and associated road gulley connections to around 15 gullies. This will necessitate further remedial work – but given the long-standing problems with the poor road surface, length of time to investigate and impending UCI race, NYCC had taken a pragmatic decision to complete the work now. Copgrove road would be completed over the next few Sundays prior to the UCI cycle race.
