

Kemberton Parish Council
Minutes of Parish Council Meeting
held in Kemberton Village Hall
on Wednesday 9th January 2019 at 7.30pm.

1. CHAIR WELCOME AND ANNOUNCEMENTS

The Chair welcomed everyone to the meeting and wished them Happy New Year. He welcomed Cllr Michael Wood to the meeting, hoping he felt much better.

2. APOLOGIES

Cllr James Rennison sent his apologies in advance of the meeting

3. DISCLOSABLE PECUNIARY INTERESTS

5. REPORT FROM SHROPSHIRE COUNCILLOR

Cllr Michael Wood thanked the Parish Council for its card and well wishes. He is starting to get back into things again.

Finances:-

News from Shire Hall included the likelihood of a budget levy of 3.99%.

The Highways budget is short of money, with another £5M gap this year as last year. The Central Government grant does not make up the gap taking into account both years' shortfall. There are continuing budget pressures from Adult Social Care and Cared for Children, both of which are statutory duties where needs must be met as they arise.

Highway issues:-

-Problems continue at Stableford Bridge. There is money for traffic lights but it will be April before money can be released; £700K is needed from capital funds.

-Kier share prices are in fall. The situation is being watched. There is a shortage of big companies who want to do council work maintenance.

- The 'rat run' and roads around Worfield are likely to get worse. Cllr Wood said he is concerned about this and will be having another meeting with other local Councillors on 16th January where he will raise this as an issue.

- lorry queues building up by the Cowgreaves site is a problem that has arisen recently, email with attached photos have been sent by Cllr James Rennison to Cllr Wood

Cllr Angela Blount commented that the potholes on Field Lane are horrendous. A local resident has had a near accident when on a mobility scooter.

Cllr Michael Wood said that if people had have complaints it would be helpful if they used the pothole porthole on the Shropshire Council website as this collates information. He will also follow up complaints if necessary.

Cllr Martyn Bidgood, in the Chair, said that it seemed there was not enough money and someone will have to prioritise expenditure.

Housing developments:-

There will be a public meeting about the Stanmore housing development site on January 17th at the Castle Hall. The site will affect other communities in the area due to the impact on traffic and facilities, so Cllr Wood encouraged Councillors to attend the event. There will be a similar event in Shifnal. Councillor Mark Lea suggested making a delegation.

6. PUBLIC PARTICIPATION SESSION

Local residents (not present at the meeting) had written to the Chair with an update on an affordable housing project. Plans are underway following consultation with Shropshire Council.

7. MINUTES

It was **Resolved** to approve and sign the minutes dated 14th November 2018. Proposed by Cllr Giles Greenwood, seconded by Cllr Phillip Jones, all in favour.

8. MATTERS ARISING

9. HIGHWAYS

The Parish Clerk reported that she had contacted Highways regarding safety measures on the junction but had not received a reply to date.

Cllr Martyn Bidgood, in the Chair, reported that the police had treated the recent accident on the junction as fatal. The man injured in the accident has survived but has suffered brain damage.

Cllr Martyn Bidgood also said that cost of calling out security services to serious accidents of this severity will exceed the cost of safety measures. He has considered getting in touch with the Police and Crime Commissioner's Office about their Safer Roads Fund. Signage warning of the speed restriction at the junction could help.

Cllr Michael Wood said that Norton is a local example for where illuminated speed restriction signs have proved successful. It has also been successful at Cressage.

10. CORRESPONDENCE

A reply has been received from Phillip Dunne M.P in response to the Parish Council's letter about the volume of traffic on local lanes due to the Renew relocation. Mr Dunne has written to the Chief Executive at Shropshire Council to raise his concerns.
