MINUTES OF THE PARISH COUNCIL MEETING HELD AT 7.30pm ON 21st January 2021 BY REMOTE VIDEO CALL

The meeting could not be conducted face-to-face due to the restrictions imposed during the Coronavirus pandemic. The Council took advantage of The Local Authorities (Coronavirus) (Flexibility of Local Authority Meetings) (England) Regulations 2020 allowing local authorities to conduct meetings remotely.

60.20 Apologies for Absence

Cllr S. Green was absent due to a work commitment

61.20 Disclosable Pecuniary Interests

- a) No disclosable pecuniary interests were declared
- b) There were no applications for a dispensation regarding disclosable pecuniary interests

62.20 Public Participation session/Matters of Concern/Parish Matters

A member of the public, Mr James Healey, was present for part of the meeting. Mr Healey is a candidate standing in the forthcoming Shropshire Council local elections attending the meeting to introduce himself to the Council.

63.20 To approve the minutes of the Parish Council Meeting held on 19 November 2020

The minutes of the previous meeting had been circulated.

It was proposed by Councillor Roberts and seconded by Councillor Davies and

That the minutes of the Parish Council Meeting held on 19 November 2020 be accepted as a true record.

The minutes were signed accordingly.

64.20 Matters arising from the minutes of the Parish Council Meeting of 19 November 2020 a) Update on A458/Cound park speeding traffic (min ref 36.20 & 50.20)

The results from the speed strips placing at either side of the entrance to Cound Park had been received from Shropshire Council. These indicate that the vast majority of road users are well within the 60mph speed limit although there are a significant proportion in the 60-65mph bracket, and a handful clocked doing speeds in excess of 85mph.

After some discussion and different suggestions as to what steps (if any) should now be taken Cllr Wild re-iterated that the police have to agree to any speed reduction as it is an 'A' road. The police will not reduce a speed limit without the stats to back it up, and if any steps are to be taken Steve Brown of Shropshire Highways needs to be 'on side' to push the case forward.

It was agreed that this would be an agenda item at the March 18th meeting Steve Brown and Chris Lewis (and/or other Cound Park residents) invited to attend.

ACTION: Clerk to email Steve Brown and Chris Lewis re attendance at 18th March meeting.

b) **Update on Clerk's recruitment and hand-over plan (min ref 55.20)** Cllr Scott introduced the incoming Clerk, Lisa Harris, to the Council and Cllr Roberts gave a resumé of Lisa's experience to date.

Lisa will commence as Clerk/RFO on 1st February.

65.20 To receive report from Shropshire Councillor

- Cllr Wild welcomed the new Clerk, stressing that if she could be of any assistance she would be pleased to help wherever possible.
- Cllr Wild had reported a broken drain at Bull Hollow to Jonathan Stigwood (Shropshire Highways Drainage Engineer). Also reported the excess mud on the road at Evenwood Farm, now cleared up.
- Cllr Scott reported that he had needed to chase up for Shropshire Council support relating to the gritter/snowplough a couple of times recently. No service/maintenance had happened until he requested it and the salt was very late in being delivered and only recently received. Cllr Wild said she would follow up on this.

66.20 To receive the defibrillator audit check for the period

Councillor Roberts had performed the audit checks for the period up to 17th January 2021. The British Heart Foundation had asked for an update recently. There were no issues to report.

67.20 To consider appointment of Highways Maintenance Contractor for 2021/22

Another contractor had expressed an interest in quoting for the 2021/22 contract. It was decided to delay the appointment to the March meeting to give the interested party time to respond.

b) Bank reconciliation to 15 January 2021

The bank was reconciled at £6,009.82, being the online banking balances on the date the meeting Agenda was prepared. The bank reconciliation was agreed and signed by the Chairman.

c) Projected year end accounts 2020/21 and budget/precept 2021/22

The Clerk presented a schedule showing comparisons of budgeted and actual receipts and payments for the current year and a suggested budget for the next financial year. As last year the budget and precept requirement assumed that Shropshire Council will award an Environmental Maintenance Grant (EMG) to the Parish. The proposal was to leave the precept at the same level as the three previous years at £5,756. The projected reserves at the end of 2021/22 on that basis were £4,981, being approx. 9.6 months expenditure at 2021/22 budgeted levels. This was regarded as a necessary 'safe level' to cover for eventualities such as the EMG being withdrawn.

It was proposed by Cllr Hall and seconded by Cllr Smith and

to accept the budget as presented and to set the precept for 2021/22 at £5,756.
